To appropriate \$2,000,000 within the Tree Protection Fund (15304) to be spent on the City's tree planting program (the "630-CITY Tree Planting Program"), to plant trees within public rights-of-way in Duval County in locations where adjacent property owners have requested trees through 630-CITY. The Program funds will be expended in this way: when a property owner enlists the help of the City through 630-CITY asking for a new tree to be installed in the right-of-way adjacent to their property, the Department of Public Works may use Fund 15304 to install a tree approved in accordance with the Approved Trees for City Right-of-Way Landscaping and Parks. The location and species must be approved by a City Arborist.
