4 **ORDINANCE 2020-475-E**

5 AN ORDINANCE ADOPTING A SMALL-SCALE AMENDMENT
6 TO THE FUTURE LAND USE MAP SERIES OF THE 2030
7 *COMPREHENSIVE PLAN* BY CHANGING THE FUTURE LAND
8 USE DESIGNATION FROM NEIGHBORHOOD COMMERCIAL
9 (NC) AND RESIDENTIAL-PROFESSIONAL-INSTITUTIONAL
10 (RPI) TO COMMUNITY/GENERAL COMMERCIAL (CGC) ON
11 APPROXIMATELY 1.0± ACRES LOCATED IN COUNCIL
12 DISTRICT 6 AT 5050 SUNBEAM ROAD, BETWEEN
13 PHILIPS HIGHWAY AND SAN JOSE BOULEVARD, OWNED
14 BY RIMOUN N. SAFAR, AS MORE PARTICULARLY
15 DESCRIBED HEREIN, PURSUANT TO APPLICATION
16 NUMBER L-5384-19C; PROVIDING A DISCLAIMER THAT
17 THE AMENDMENT GRANTED HEREIN SHALL NOT BE
18 CONSTRUED AS AN EXEMPTION FROM ANY OTHER
19 APPLICABLE LAWS; PROVIDING AN EFFECTIVE DATE.

21 **WHEREAS**, pursuant to the provisions of Section 650.402(b),
22 *Ordinance Code*, and Section 163.3187(1), *Florida Statutes*, an
23 application for a proposed Small-Scale Amendment to the Future Land
24 Use Map series (FLUMs) of the *2030 Comprehensive Plan* to change the
25 Future Land Use designation from Neighborhood Commercial (NC) and
26 Residential-Professional-Institutional (RPI) to Community/General
27 Commercial (CGC) on 1.0± acres of certain real property in Council
28 District 6, was filed by the owner, Rimoun N. Safar; and

29 **WHEREAS**, the Planning and Development Department reviewed the
30 proposed revision and application and has prepared a written report
31 and rendered an advisory recommendation to the City Council with

1 respect to the proposed amendment; and

2 **WHEREAS**, the Planning Commission, acting as the Local Planning
3 Agency (LPA), held a public hearing on this proposed amendment,
4 with due public notice having been provided, reviewed and
5 considered comments received during the public hearing and made its
6 recommendation to the City Council; and

7 **WHEREAS**, the Land Use and Zoning (LUZ) Committee of the City
8 Council held a public hearing on this proposed amendment to the
9 *2030 Comprehensive Plan*, pursuant to Chapter 650, Part 4, *Ordinance*
10 *Code*, considered all written and oral comments received during the
11 public hearing, and has made its recommendation to the City
12 Council; and

13 **WHEREAS**, the City Council held a public hearing on this
14 proposed amendment, with public notice having been provided,
15 pursuant to Section 163.3187, *Florida Statutes* and Chapter 650,
16 Part 4, *Ordinance Code*, and considered all oral and written
17 comments received during public hearings, including the data and
18 analysis portions of this proposed amendment to the *2030*
19 *Comprehensive Plan* and the recommendations of the Planning and
20 Development Department, the Planning Commission and the LUZ
21 Committee; and

22 **WHEREAS**, in the exercise of its authority, the City Council
23 has determined it necessary and desirable to adopt this proposed
24 amendment to the *2030 Comprehensive Plan* to preserve and enhance
25 present advantages, encourage the most appropriate use of land,
26 water, and resources consistent with the public interest, overcome
27 present deficiencies, and deal effectively with future problems
28 which may result from the use and development of land within the
29 City of Jacksonville; now, therefore

30 **BE IT ORDAINED** by the Council of the City of Jacksonville:

31 **Section 1. Purpose and Intent.** This Ordinance is adopted

1 to carry out the purpose and intent of, and exercise the authority
2 set out in, the Community Planning Act, Sections 163.3161 through
3 163.3248, *Florida Statutes*, and Chapter 166, *Florida Statutes*, as
4 amended.

5 **Section 2. Subject Property Location and Description.**

6 The approximately 1.0± acres (R.E. No. 149085-0020) are located in
7 Council District 6 at 5050 Sunbeam Road, between Philips Highway
8 and San Jose Boulevard, as more particularly described in **Exhibit**
9 **1**, dated April 9, 2020, and graphically depicted in **Exhibit 2**, both
10 **attached hereto** and incorporated herein by this reference (Subject
11 Property).

12 **Section 3. Owner and Applicant Description.** The Subject

13 Property is owned by Rimoun N. Safar. The applicant is Rimoun N.
14 Safar, 2340 Saragossa Avenue, Jacksonville, Florida 32217; (904)
15 333-5786.

16 **Section 4. Adoption of Small-Scale Land Use Amendment.**

17 The City Council hereby adopts a proposed Small-Scale revision to
18 the Future Land Use Map series of the *2030 Comprehensive Plan* by
19 changing the Future Land Use Map designation from Neighborhood
20 Commercial (NC) and Residential-Professional-Institutional (RPI) to
21 Community/General Commercial (CGC), pursuant to Application Number
22 L-5384-19C.

23 **Section 5. Applicability, Effect and Legal Status.** The

24 applicability and effect of the *2030 Comprehensive Plan*, as herein
25 amended, shall be as provided in the Community Planning Act,
26 Sections 163.3161 through 163.3248, *Florida Statutes*, and this
27 Ordinance. All development undertaken by, and all actions taken in
28 regard to development orders by governmental agencies in regard to
29 land which is subject to the *2030 Comprehensive Plan*, as herein
30 amended, shall be consistent therewith as of the effective date of
31 this amendment to the plan.

1 **Section 6. Effective date of this Plan Amendment.**

2 (a) If the amendment meets the criteria of Section 163.3187,
3 *Florida Statutes*, as amended, and is not challenged, the effective
4 date of this plan amendment shall be thirty-one (31) days after
5 adoption.

6 (b) If challenged within thirty (30) days after adoption, the
7 plan amendment shall not become effective until the state land
8 planning agency or the Administration Commission, respectively,
9 issues a final order determining the adopted Small-Scale Amendment
10 to be in compliance.

11 **Section 7. Disclaimer.** The amendment granted herein shall
12 **not** be construed as an exemption from any other applicable local,
13 state, or federal laws, regulations, requirements, permits or
14 approvals. All other applicable local, state or federal permits or
15 approvals shall be obtained before commencement of the development
16 or use and issuance of this amendment is based upon
17 acknowledgement, representation and confirmation made by the
18 applicant(s), owner(s), developer(s) and/or any authorized agent(s)
19 or designee(s) that the subject business, development and/or use
20 will be operated in strict compliance with all laws. Issuance of
21 this amendment does **not** approve, promote or condone any practice or
22 act that is prohibited or restricted by any federal, state or local
23 laws.

24 **Section 8. Effective Date.** This Ordinance shall become
25 effective upon signature by the Mayor or upon becoming effective
26 without the Mayor's signature.
