AN ORDINANCE APPROPRIATING \$100,000 FROM THE NORTHWEST JACKSONVILLE ECONOMIC DEVELOPMENT ("NWJEDF"), INTEREST INCOME, FUND TO THE NORTHWEST JACKSONVILLE ECONOMIC DEVELOPMENT FUND, SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORGANIZATIONS, FOR THE PURPOSE OF PROVIDING A NORTHWEST JACKSONVILLE BUSINESS INFRASTRUCTURE GRANT (THE "BIG GRANT") TO PHOENIX PRODUCTS, LLC ("COMPANY") TO SUPPORT THE CONSTRUCTION OF A NEW ADMINISTRATIVE BUILDING (THE "PROJECT"), AS INITIATED BY B.T. 20-118; MAKING CERTAIN FINDINGS, AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER, FOR AND ON BEHALF OF THE CITY, THEECONOMIC DEVELOPMENT AGREEMENT ("EDA") BETWEEN THE CITY AND COMPANY; AUTHORIZING APPROVAL OF TECHNICAL AMENDMENTS BY THE EXECUTIVE DIRECTOR OF THE OFFICE OF ECONOMIC DEVELOPMENT ("OED"); AFFIRMING THE PROJECT'S COMPLIANCE WITH THE NWJEDF GUIDELINES APPROVED AND ADOPTED BY ORDINANCE 2016-779-E; PROVIDING FOR CITY OVERSIGHT BY THE OED; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Phoenix Products, LLC (the "Company"), a subsidiary of Ring Power Corporation, is seeking public investment through the Northwest Jacksonville Economic Development Fund in the amount of \$100,000.00, which consists of a Northwest Business Infrastructure Grant (the "BIG Grant"), in order to construct a new administrative building (the "Project"); and

WHEREAS, the Company estimates capital investment of approximately \$2,144,000 and anticipates the creation of additional full-time equivalent job opportunities in Jacksonville, as further described in the Project Summary, attached hereto as Exhibit 1 and incorporated herein by this reference; and

WHEREAS, for the reasons more fully described in the Project Summary, the payment of the BIG Grant in the aforesaid amount serves a paramount public purpose; and

WHEREAS, the recommended level of assistance is within Public Investment Guidelines for a Northwest BIG Grant; and

WHEREAS, the Project will have a positive return of investment
for the City; and

WHEREAS, the Office of Economic Development (OED) has reviewed the application submitted by the Company for community development and, together with representatives of the City, has negotiated an Economic Development Agreement (EDA) and, based upon the contents of the EDA, has determined the EDA and the uses contemplated therein to be in the public interest, and has determined that the public actions and financial assistance contemplated in the EDA take into account and give consideration to the long-term public interests and public interest benefits to be achieved by the City; and

WHEREAS, the Company has requested the City to enter into an EDA in substantially the form placed On File with the Office of Legislative Services Division; now therefore,

BE IT RESOLVED by the Council of the City of Jacksonville: 1 2 Section 1. Findings. Ιt is hereby ascertained, 3 determined, found and declared as follows: The recitals set forth herein are true and correct. 4 (a) The location of the Company's Project in Jacksonville, 5 6 Florida, is more particularly described in the EDA. The Project 7 will promote and further the public and municipal purposes of the 8 City. 9 The provision of the City's assistance as identified in (C) 10 the EDA is necessary and appropriate to make the Project feasible, 11 and the City's assistance is reasonable and not excessive, taking into account the needs of the Company to make the Project 12 13 economically and financially feasible and the extent of the public 14 benefits expected to be derived from the Project. The Company is qualified to carry out and complete the 15 construction and equipping of the Project, in accordance with the 16 17 EDA. Section 2. 18 Appropriation. Development Fund, Subsidies and Contributions to Private Organizations, to provide a Northwest Jacksonville Economic Development Fund Business Infrastructure Grant ("BIG") to the Company to assist in funding infrastructure improvements to support construction of a new administrative building.

Section 3. Purpose. The purpose of the appropriation in Section 2 is to provide the Company funding in the form of a Northwest Jacksonville Business Infrastructure Grant in an amount not to exceed \$100,000 to fund infrastructure improvements needed to complete the Project, including but not limited to utility upgrades, storm water improvements, and an expanded assembly/staging area within the existing confines of the site.

Section 4. Economic Development Agreement approved. The Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver, for and on behalf of the City, an EDA between the City and the Company, in substantially the form placed On File with the Office of Legislative Services (with such "technical" changes as herein authorized), for the purpose of implementing the recommendations of the OED as set forth herein and further described in the Project Summary, attached hereto as Exhibit 1.

The EDA may include such additions, deletions, and changes as may be reasonable, necessary, and incidental for carrying out the purposes thereof, as may be acceptable to the Mayor or his designee, with such inclusion and acceptance being evidenced by execution of the EDA by the Mayor or his designee. No modification of the EDA may increase the financial obligations or the liability of the City and any such modification shall be technical only and shall be subject to appropriate legal review and approval of the General Counsel or his or her designee and all other appropriate

action required by law. "Technical" is herein defined as including, but not limited to, changes in legal descriptions and surveys, descriptions of infrastructure improvements and/or any road project, ingress and egress, easements and rights of way, performance schedules (provided that no performance schedule may be extended for more than one year without City Council approval), design standards, access, and site plans which have no financial impact.

Authorized Section 5. Designation of Official/OED Contract Monitor. The Mayor is designated as the authorized official of the City for the purpose of executing and delivering notes, and documents and furnishing contracts, information, data, and documents for the EDA as may be required and otherwise to act as the authorized official of the City in connection with the EDA, and is further authorized to designate one or more other officials of the City to exercise any of the foregoing authorizations and to furnish or cause to be furnished such information and take or cause to be taken such action as may be necessary to enable the City to implement the EDA according to its terms. The OED is hereby required to administer and monitor the EDA and to handle the City's responsibilities thereunder, including the City's responsibilities under the EDA working with and supported by all relevant City departments.

Section 6. Further Authorizations. The Mayor, or his designee, and the Corporation Secretary, are hereby authorized to execute the EDA and all other contracts and documents and otherwise take all necessary action in connection therewith and herewith. The Executive Director of the OED, as contract administrator, is authorized to negotiate and execute all necessary changes and amendments to the EDA and other contracts and documents, to effectuate the purposes of this legislation without further Council

11	Section 9. Effective Date. This ordinance shall become

effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
