6 **ORDINANCE 2020-592-E**

7 AN ORDINANCE APPROVING THE ISLE OF PALMS  
8 SPECIAL DISTRICT AMENDED FISCAL YEAR 2020-2021  
9 BUDGET, PER ORDINANCE 2011-724-E AND SECTION  
10 189.02, *FLORIDA STATUTES*; PROVIDING AN  
11 EFFECTIVE DATE.

13 **WHEREAS**, the City of Jacksonville established the Isle of  
14 Palms Special District (the "District"), per Ordinance 2011-724-E  
15 and section 189.02, *Florida Statutes*, a dependent special district  
16 for the purpose of dredging the Isle of Palms canal system; and

17 **WHEREAS**, in order for the District to qualify as a dependent  
18 special district per section 189.02, *Florida Statutes*, the City, in  
19 Ordinance 2011-724-E, required the District to submit its proposed  
20 budget to the City Council every year by April 1<sup>st</sup>; and

21 **WHEREAS**, the District submitted its proposed Fiscal Year 2020-  
22 2021 budget, which was approved by the City Council in Ordinance  
23 2020-217-E, that set the non-ad valorem assessment per parcel at  
24 \$950.00; and

25 **WHEREAS**, on September 9, 2020, the District adopted Resolution  
26 20-03 which increased the non-ad valorem assessment to be levied on  
27 property from \$950.00 per parcel to \$1,000.00 per parcel, and the  
28 District adopted a modified Fiscal Year 2020-2021 budget through  
29 Resolution 20-03; and

30 **WHEREAS**, the Isle of Palms Special District submitted the  
31 amended Fiscal Year 2020/2021 budget to the City Council for

1 approval pursuant to Ordinance 2011-724-E, a copy of the Board  
2 Resolution is attached hereto as **Revised Exhibit 1**, labeled as  
3 "Revised Exhibit 1, Rev Budget Schedule, October 20, 2020 -  
4 Finance"; and

5 **WHEREAS**, the City Council finds that the Isle of Palms Special  
6 District amended Fiscal Year 2020/2021 budget in **Revised Exhibit 1**,  
7 labeled as "Revised Exhibit 1, Rev Budget Schedule, October 20,  
8 2020 - Finance" should be approved; now therefore

9 **BE IT ORDAINED** by the Council of the City of Jacksonville:

10 **Section 1. Approval of Isle of Palms Special District**  
11 **Amended Fiscal Year 2020/2021 Budget.** The Isle of Palms Special  
12 District amended Fiscal Year 2020/2021 budget, attached hereto as  
13 **Revised Exhibit 1**, labeled as "Revised Exhibit 1, Rev Budget  
14 Schedule, October 20, 2020 - Finance", is hereby approved.

15 **Section 2. Effective Date.** This ordinance shall become  
16 effective upon signature by the Mayor, or upon becoming effective  
17 without the Mayor's signature.
