Malnove is a manufacturer of packaging materials for a variety of customers primarily in the packaged foods industry. The company was founded in 1948 by Paul Malnove in Omaha, Nebraska. Malnove operates manufacturing facilities in Omaha, Nebraska, Clearfield, Utah and Jacksonville, Florida. Malnove expanded to Jacksonville in 1981 and in 1998 purchased a site within Imeson International Industrial Park and constructed a 235,000 square foot manufacturing facility. Additionally, they lease another 100,500 square feet of warehouse space within Imeson. Malnove currently employs 182 persons in Jacksonville. The average annual wage of their current workforce is \$48,250 (\$23.20 per hour), plus benefits. The company is evaluating all three of their current facilities for the proposed expansion. If Jacksonville is selected, they propose to add a manufacturing line and purchase additional machinery and equipment. The private capital investment associated with the proposed expansion is estimated to cost \$7.4 million. The expansion is expected to create 10 new full-time manufacturing jobs within 36 months from project completion. The new jobs would be entry-level jobs within the finishing department paying an average of \$36,500 (\$17.54 per hour), plus benefits.

Malnove has indicated that the City of Jacksonville's financial incentive proposed is a material factor in the decision to expand their manufacturing facility in Jacksonville versus either Omaha, Nebraska or Clearfield, Utah.

The public investment proposed is a Recaptured Enhanced Value (REV) Grant at the level of 50% of the incremental net increase in the ad valorem portion of the tangible property taxes resulting from the purchase and installation of machinery and equipment costing \$7.4 million. The term of the proposed REV Grant is five (5) years. The estimated value of the REV Grant over the five (5) year period is \$160,000.

The project has a positive Return on Investment for the City of Jacksonville.</u>
