AN ORDINANCE APPROVING THE WAIVER OF MINIMUM ROAD FRONTAGE APPLICATION WRF-20-28, LOCATED IN COUNCIL DISTRICT 14 AT 2841 DORIC AVENUE, BETWEEN MCGIRTS BOULEVARD AND BALTIC STREET (R.E. NO. 101492-0000) AS DESCRIBED HEREIN, OWNED BY CHERYL P. LAUCKS, REQUESTING TO REDUCE THE MINIMUM ROAD FRONTAGE REQUIREMENTS FROM 72 FEET TO 62.50 FEET FOR TWO LOTS IN ZONING DISTRICT RESIDENTIAL LOW DENSITY-90 (RLD-90), AS 13 DEFINED AND CLASSIFIED UNDER THE ZONING CODE; PROVIDING A DISCLAIMER THAT THE WAIVER GRANTED 15 HEREIN SHALL NOT BE CONSTRUED AS AN EXEMPTION FROM ANY OTHER APPLICABLE LAWS; PROVIDING AN 17 EFFECTIVE DATE.

20 WHEREAS, an application for a waiver of minimum road frontage, 21 On File with the City Council Legislative Services Division, was 22 filed by Brenda M. Durden, Esq., on behalf of Cheryl P. Laucks, the 23 owner of property located in Council District 14 at 2841 Doric Avenue, 24 between McGirts Boulevard and Baltic Street (R.E. No. 101492-0000) (Subject Property), requesting to reduce the minimum road frontage 25 26 from 72 feet to 62.50 feet for two lots in Zoning District Residential Low Density-90 (RLD-90); and 27

28 WHEREAS, the Planning and Development Department has considered 29 the application and all attachments thereto and has rendered an 30 advisory recommendation; and

WHEREAS, the Land Use and Zoning Committee, after due notice

held a public hearing and having duly considered both the testimonial 1 2 and documentary evidence presented at the public hearing, has made 3 its recommendation to the Council; and

WHEREAS, taking into consideration the above recommendations and 5 all other evidence entered into the record and testimony taken at the public hearings, the Council finds that: (1) there are practical or 6 7 economic difficulties in carrying out the strict letter of the regulation; (2) the request is not based exclusively upon the desire 8 9 to reduce the cost of developing the site or to circumvent the 10 requirements of Chapter 654 (Code of Subdivision Regulations); (3) the proposed waiver will not substantially diminish property values 11 in, nor alter the essential character of, the area surrounding the 12 site and will not substantially interfere with or injure the rights 13 of others whose property would be affected by the waiver; (4) there 14 15 is a valid and effective easement for adequate vehicular access connected to a public street which is maintained by the City or an 16 17 approved private street; and (5) the proposed waiver will not be detrimental to the public health, safety or welfare, result in 18 additional expense, the creation of nuisances or conflict with any 19 20 other applicable law; now, therefore

21 BE IT ORDAINED by the Council of the City of Jacksonville: 22 Section 1. Adoption of Findings and Conclusions. The 23 Council has reviewed the record of proceedings and the Staff Report 24 of the Planning and Development Department and held a public hearing 25 concerning application for waiver of road frontage WRF-20-28. Based 26 upon the competent, substantial evidence contained in the record, the 27 Council hereby determines that the requested waiver of road frontage 28 meets the criteria for granting a waiver contained in Chapter 656, 29 Ordinance Code. Therefore, Application WRF-20-28 is hereby approved. 30 Section 2. Owner and Description. The Subject Property is

owned by Cheryl P. Laucks, and is legally described in Exhibit 1, 31

Section 3. Distribution Legislative 4 by Services. Legislative Services is hereby directed to mail a copy of this 5 legislation, as enacted, to the applicant and any other parties to 6 7 this matter who testified before the Land Use and Zoning Committee or otherwise filed a qualifying written statement as defined in 8 9 Section 656.140(c), Ordinance Code.

10 Section 4. **Disclaimer.** The waiver of road frontage granted herein shall **<u>not</u>** be construed as an exemption from any other 11 applicable local, state, or federal laws, regulations, requirements, 12 permits or approvals. All other applicable local, state or federal 13 permits or approvals shall be obtained before commencement of the 14 development or use and issuance of this waiver of road frontage is 15 based upon acknowledgement, representation and confirmation made by 16 17 the applicant(s), owner(s), developer(s) and/or any authorized agent(s) or designee(s) that the subject business, development and/or 18 19 use will be operated in strict compliance with all laws. Issuance of 20 this waiver of road frontage does **not** approve, promote or condone any 21 practice or act that is prohibited or restricted by any federal, 22 state or local laws.

23 Section 5. Effective Date. The enactment of this Ordinance 24 shall be deemed to constitute a quasi-judicial action of the City 25 Council and shall become effective upon signature by the Council 26 President and Council Secretary. Failure to exercise the waiver, if herein granted, by the commencement of the use or action herein 27 28 approved within one year of the effective date of this legislation 29 shall render this waiver invalid and all rights arising therefrom 30 shall terminate.
