9 DONATIONS TO TRUE YOUTH ASSOCIATION (\$10,000),
10 LOVE FELLOWSHIP CHRISTIAN CENTER (\$10,000), US
11 AND OUR CHILDREN, INC. (\$10,000), AND STEP-BY-
12 STEP 4 HELP FOUNDATION, INC. (\$10,000) IN
13 ACCORDANCE WITH SECTION 932.7055(5), FLORIDA
14 STATUTES, FOR PROJECTS THAT MEET THE CRIME
15 PREVENTION AND/OR SAFE NEIGHBORHOODS GOALS AND
16 OBJECTIVES, AS INITIATED BY REVISED B.T. 20-
17 116; PROVIDING FOR CITY OVERSIGHT BY THE
18 JACKSONVILLE SHERIFF'S OFFICE IN COORDINATION
19 WITH THE KIDS HOPE ALLIANCE; PROVIDING AN
20 EFFECTIVE DATE.

22 **BE IT ORDAINED** by the Council of the City of Jacksonville:

23 **Section 1. Appropriation.** For the 2020-2021 fiscal year,
24 within the City's budget, there is hereby appropriated the
25 indicated sum(s) from the account(s) listed in subsection (a) to
26 the account(s) listed in subsection (b):

28 as "Revised Exhibit 1, Revised B.T. 20-116, November 2, 2020 -
29 NCSPHS" and incorporated herein by this reference)

5 (c) Explanation of Appropriation

6 The funding above is an appropriation from the Special
7 Law Enforcement Trust Fund (the "Fund") to support and
8 administer the Crime Prevention and/or Safe Neighborhoods
9 Programs (the "Program") for the 2020-2021 fiscal year.

10 **Section 2. Purpose.** The purpose of the appropriation in

11 Section 1 is to provide donations to the following organizations,
12 in the stated amounts, to support the goals and objectives of the
13 Program: True Youth Association (\$10,000), Love Fellowship
14 Christian Center (\$10,000), Us and Our Children, Inc. (\$10,000),
15 and Step-By-Step 4 Help Foundation, Inc. (\$10,000). This allocation
16 supports drug treatment, drug abuse education, drug prevention,
17 crime prevention, safe neighborhoods, and school resource officer
18 program services to the citizens of the City of Jacksonville, Duval
19 County, Florida. A Certification from the Jacksonville Sheriff's
20 Office that the subject appropriation from the Special Law
21 Enforcement Trust Fund complies with Section 932.7055, Florida
22 Statutes, is attached hereto as "**Revised Exhibit 2**", labeled as
23 "Revised Exhibit 2, Rev Certification, November 2, 2020 - NCSPHS"
24 and incorporated herein by this reference.

25 **Section 3. Oversight.** The Jacksonville Sheriff's Office

26 shall oversee the Program described herein in coordination with
27 the Kids Hope Alliance who shall be responsible for administration
28 of the Program requirements.

29 **Section 4. Effective Date.** This ordinance shall become

30 effective upon signature by the Mayor or upon becoming effective
31 without the Mayor's signature.
