A RESOLUTION HONORING AND COMMENDING RONNIE KING, II FOR HIS YEARS OF SERVICE AS A MEMBER AND CHAIR OF THE BOARD OF LIBRARY TRUSTEES; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Jacksonville Public Library relies on a 12-member volunteer board of trustees for its policy and planning; and

WHEREAS, trustees of the Library Board are appointed by the Mayor of Jacksonville and confirmed by the City Council for up to three four-year terms; and

WHEREAS, Ronnie King, II has served in the capacity of trustee, Vice-Chair and Chair of the Board of Library Trustees during the past nine years; and

WHEREAS, during his tenure, Trustee King extended his service to the youth of Jacksonville through the Library by holding free National Society of Black Engineers coding workshops; and

WHEREAS, in his first year as Chair of the Board of Library Trustees, Mr. King joined the Library in celebrating the selection of Jacksonville Public Library as "Library of the Year" by the Florida Library Association; and

WHEREAS, following the retirement of library director Barbara Gubbin, Trustee King led the library director search committee which succeeded in selecting new library director Tim Rogers; and

WHEREAS, resulting from annual strategic planning sessions which Trustee King oversaw, the Library showed its first increase in 10 years in both the number of cardholders and in the volume of

materials circulated; and

WHEREAS, Trustee King's advocacy and leadership in planning efforts were critical in securing several highly valuable capital improvements for the Library including, but not limited to, the much-needed renovation of the children's areas at Webb Wesconnett and Highlands Regional Libraries, planned renovation or replacement of libraries in Jacksonville's Urban Core, and the Library's 22nd and long-anticipated physical location in the Oceanway area; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:
