Explanation of Appropriation - The funding above is being (C) appropriated from the Social Justice and Community Investment Special Committee Contingency and utilized by WIT and FSCJ for the Operation Boost! program.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding for the Operation Boost! program, as more fully described in **Exhibit 2** attached hereto. The Operation Boost! program will provide recruitment, training and employment assistance to low-income students and students who face barriers to employment. \$100,000 in funding will be used by WIT to provide cost free training to 50 students who face barriers to employment and recidivism. \$100,000 in funding will be used by FSCJ to create one

hundred \$750 scholarships for low-income students (\$75,000) and to create a Student Emergency Assistance Fund for low-income students (\$25,000).
