City of Jacksonville and Rutgers Plaza II, LLC (the "Lease"), in substantially the same form as has been placed **On File** with the Office of Legislative Services. The Lease provides for use of approximately 6,000 square feet of space at the Rutgers Plaza Shopping Center by the Jacksonville Sheriff's Office as a substation, subject to the terms and conditions outlined therein. The Lease has an initial term of ten (10) years beginning September 1, 2020 at an initial rental rate of \$6,500.00 per month, with an escalation rate of three percent (3%) per year.

Section 2. Oversight Department. The Real Estate Division, Public Works Department, shall provide initial oversight of acquiring the Lease and the Jacksonville Sheriff's Office shall thereafter provide oversight of management and administration of the Lease.

Section 3. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
