ORDINANCE APPROPRIATING \$85,000 ΑN FROM SPECIAL EVENTS FLORIDA GEORGIA GAME CONTINGENCY TO THE FIRE WATCH - NORTHEAST FLORIDA VETERANS' SUICIDE PREVENTION AGENCY FUND VETERANS' SUICIDE PREVENTION FUND ΤО PROGRAMS AND ACTIVITIES; PURPOSE; PROVIDING FOR OVERSIGHT BY THE OFFICE OF GRANTS AND CONTRACT COMPLIANCE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

veterans' suicide in Northeast Florida, subject to the Interlocal Agreement terms.

Section 2. The purpose of the appropriation Purpose. above is to fund programs and activities authorized by the Northeast Florida Fire Watch Council for the purpose of preventing veterans' suicide in Northeast Florida, subject to the Interlocal Agreement terms. The Fire Watch Council is a coordinated effort between the City of Jacksonville and Baker, Clay, Nassau and St. Johns Counties to end veteran suicide in the region. It coordinates and organizes existing resources to combat the veteran suicide epidemic partnership with local, state, and federal agencies, private donors, The funding is being transferred media outlets, and nonprofits. from funds authorized for the Florida Georgia Game Contingency account as these funds were reserved but not utilized for expenses related to the Florida Georgia game taking place on November 7, 2020.

Section 3. Oversight. The Office of Grants and Contract Compliance shall oversee and provide administrative assistance to the Fire Watch Council as provided in the Interlocal Agreement.

Section 4. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
