NO. 030087-0000) AS DESCRIBED 9 HEREIN, OWNED ΒY CAMP ALLEN, LLC, FROM INDUSTRIAL BUSINESS PARK (IBP) DISTRICT 10 ΤO PLANNED UNIT DEVELOPMENT (PUD) DISTRICT, 11 AS DEFINED AND CLASSIFIED UNDER THE ZONING CODE, TO 12 13 PERMIT INDUSTRIAL AND COMMERCIAL USES, AS DESCRIBED IN THE 6242 OLD SOUTEL COURT PUD; 14 PROVIDING A DISCLAIMER THAT THE REZONING GRANTED 15 HEREIN SHALL NOT BE CONSTRUED AS AN EXEMPTION 16 FROM ANY OTHER APPLICABLE LAWS; PROVIDING AN 17 18 EFFECTIVE DATE.

WHEREAS, Camp Allen, LLC, the owner of approximately 1.43± 20 21 acres, located in Council District 10 at 6242 Old Soutel Court, 22 between Pickett Drive and Old Soutel Court (R.E. No. 030087-0000), 23 as more particularly described in Exhibit 1, dated January 12, 2021, 24 and graphically depicted in Exhibit 2, both of which are attached 25 hereto (Subject Property), has applied for a rezoning and 26 reclassification of that property from Industrial Business Park (IBP) 27 District to Planned Unit Development (PUD) District, as described in Section 1 below; and 2.8

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Property Rezoned. The Subject Property is hereby rezoned and reclassified from Industrial Business Park (IBP) District to Planned Unit Development (PUD) District. This new PUD district shall generally permit industrial and commercial uses, and is described, shown and subject to the following documents, attached hereto:

All other applicable local, state or federal permits or 1 2 approvals shall be obtained before commencement of the development or use and issuance of this rezoning is based upon acknowledgement, 3 representation and confirmation made by the applicant(s), owner(s), 4 developer(s) and/or any authorized agent(s) or designee(s) that the 5 subject business, development and/or use will be operated in strict 6 7 compliance with all laws. Issuance of this rezoning does not approve, promote or condone any practice or act that is prohibited or 8 9 restricted by any federal, state or local laws.

Section 4. Effective Date. The enactment of this Ordinance shall be deemed to constitute a quasi-judicial action of the City Council and shall become effective upon signature by the Council President and the Council Secretary.
