1           **Section 2.           Purpose.**   The purpose of the appropriation in  
2 Section 1 is to fund aerial photography and imagery contractual  
3 services rendered by Pictometry International Corp. during Fiscal  
4 Year 2019-20 to the Office of the Property Appraiser pursuant to that  
5 certain Contract for Aerial Imagery dated December 20, 2018 between  
6 the City of Jacksonville, for and on behalf of the Duval County  
7 Property Appraiser, and Pictometry International Corp. (City Contract  
8 #8668-02) which expires on September 30, 2022 (the "Service  
9 Contract").

10           **Section 3.           Oversight Department.**   The Office of the  
11 Property Appraiser shall oversee administration of the Services  
12 Contract.

13           **Section 4.           Effective Date.**   This ordinance shall become  
14 effective upon signature by the Mayor or upon becoming effective  
15 without the Mayor's signature.
