4 **ORDINANCE 2021-46**

5 AN ORDINANCE APPROPRIATING \$50,000.00 FROM THE  
6 NORTHWEST JACKSONVILLE ECONOMIC DEVELOPMENT  
7 FUND - CONTINGENCY TO THE NORTHWEST JACKSONVILLE  
8 ECONOMIC DEVELOPMENT FUND - SUBSIDIES AND  
9 CONTRIBUTIONS TO FUND A GRANT TO THE  
10 JACKSONVILLE TRANSPORTATION AUTHORITY FOR THE  
11 "DOOR-TO-STORE PROGRAM" (THE "PROGRAM"), A  
12 COMPONENT OF THE FULL-SERVICE GROCERY STORE  
13 IMPROVEMENT PROGRAM ESTABLISHED UNDER ORDINANCE  
14 2019-812-E, AS INITIATED BY B.T. 21-035;  
15 APPROVING AND AUTHORIZING THE MAYOR, OR HIS  
16 DESIGNEE, AND THE CORPORATION SECRETARY TO  
17 EXECUTE AND DELIVER THAT CERTAIN FUNDING  
18 AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND  
19 THE JACKSONVILLE TRANSPORTATION AUTHORITY TO  
20 CONTINUE THE PROGRAM FOR AN ADDITIONAL ONE (1)  
21 YEAR TERM; PROVIDING FOR CITY OVERSIGHT AND  
22 PROGRAM ADMINISTRATION BY THE OFFICE OF ECONOMIC  
23 DEVELOPMENT; PROVIDING FOR A REPORT TO THE  
24 TRANSPORTATION, ENERGY AND UTILITIES COMMITTEE;  
25 PROVIDING AN EFFECTIVE DATE.

27 **BE IT ORDAINED** by the Council of the City of Jacksonville:

28 **Section 1. Appropriation.** For the 2020-2021 fiscal year,  
29 within the City's budget, there are hereby appropriated the indicated  
30 sum(s) from the account(s) listed in subsection (a) to the account(s)  
31 listed in subsection (b):

7 (c) Explanation of Appropriation:

8 The funding above is a transfer of funds from the Northwest  
9 Jacksonville Economic Development Fund - Contingency to  
10 the Northwest Jacksonville Economic Development Fund -  
11 Subsidies and Contributions (the "Trust Fund") to fund a  
12 grant to the Jacksonville Transportation Authority (JTA)  
13 to enable the City to continue operation of the Program  
14 for an additional one (1) year term.

15 **Section 2. Purpose.** The purpose of the appropriation in  
16 Section 1 is to fund the Program for an additional one (1) year term.  
17 The Program provides complimentary on-demand transportation services  
18 to local grocery stores for residents of the Northwest Jacksonville  
19 Economic Development Area (the "Area") and incentivizes the operation  
20 of new supermarkets and healthy food programs within the Area. JTA  
21 will retain excess grant funds appropriated by the City for the first  
22 year of the Program authorized under Ordinance 2019-812-E as  
23 additional funding to support the second year of the Program, up to  
24 a maximum carryover amount of \$25,000.00. Any grant funds in excess  
25 of \$25,000.00 remaining from the first year of the Program shall be  
26 returned to the City.

27 **Section 3. Approval and authorization.** There is hereby  
28 approved, and the Mayor, or his designee, and the Corporation  
29 Secretary are hereby authorized to execute and deliver, for and on  
30 behalf of the City, that certain Funding Agreement between the City  
31 of Jacksonville and the Jacksonville Transportation Authority,
