CONTRACTS), CHAPTER 77 (KIDS HOPE ALLIANCE), ORDINANCE CODE, TO EXEMPT THE SERVICES TO BE PROVIDED BY MANAGED ACCESS TO CHILD HEALTH, INC. FROM COMPETITIVE PROCUREMENT; PROVIDING FOR OVERSIGHT BY THE KIDS HOPE ALLIANCE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2020-2021 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation:

The funding above includes \$162,865.00 in grant funds from the Office of Justice Programs, U.S. Department of Justice, with an additional appropriation of \$67,040.00 from the Kids Hope Alliance ("KHA") to cover the additional costs for the first year of the program.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to fund the first year of a comprehensive anti-gang program for youth known as "Project INSPIRE" (Identifying Needs and Supports to Partner, Intervene, Reengage and Educate youth) (the "Program") for the period beginning October 1, 2020 through September 30, 2021, with the overall term of the grant beginning October 1, 2020 and ending September 30, 2023. A copy of the

Section 3. Amending Schedule M to Ordinance 2020-511-

Department of Justice, Office of Justice Programs Juvenile Justice

E. There is hereby amended for the fiscal year 2020-2021 budget for the Kids Hope Alliance by substituting in the place of Schedule M, approved by Ordinance 2020-511-E, the Revised Schedule M, attached hereto as Exhibit 4 and incorporated herein by this reference. The Revised Schedule M will reflect additional transfers and funds appropriated herein.

Section 4. Authorization of Position. There is hereby authorized the contract manager position more fully described in R.C. 21-058, attached hereto as **Exhibit 2** and incorporated herein by this reference.

Section 5. Invoking the exception to Section 126.107(g), Ordinance Code. KHA is hereby authorized to procure services from Managed Access to Child Health, Inc. as necessary to comply with grant requirements in connection with the Program authorized in Section 1 above. Pursuant to Section 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance Code, such services are exempted from competitive solicitation because the services to be provided are being approved via authorizing legislation pursuant to this ordinance.

Section 6. Approval and Authorization. The Mayor, or his designee, and the Corporation Secretary, and/or the Chief Executive Officer of KHA are hereby authorized to execute and deliver a contract between KHA and Managed Access to Child Health, Inc. as is necessary to comply with grant requirements in connection with the Program authorized in Section 1.

Section 7. Waiver of the provisions in Chapter 77 (Kids Hope Alliance), Section 77.111(a) (Provider Contracts). The City hereby waives the provisions in Chapter 77 (Kids Hope Alliance), Section 77.111(a) (Provider Contracts) with respect to the contract with Managed Access to Child Health, Inc. approved and authorized in Section 5 of this ordinance. Section 77.111(a) requires contracts for children's services provided by third parties to be competitively procured by KHA via an evaluated bid process. This waiver is needed in order to allow KHA to meet grant requirements by directly contracting with Managed Access to Child Health, Inc. to provide Program services which was included in the approved grant application.

Section 8. Oversight Department. The Kids Hope Alliance shall oversee administration of the grant and the Program.

Section 9. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
