5 **ORDINANCE 2021-46-E**

6 AN ORDINANCE APPROPRIATING \$50,000.00 FROM THE
7 NORTHWEST JACKSONVILLE ECONOMIC DEVELOPMENT
8 FUND - CONTINGENCY TO THE NORTHWEST
9 JACKSONVILLE ECONOMIC DEVELOPMENT FUND -
10 SUBSIDIES AND CONTRIBUTIONS TO FUND A GRANT TO
11 THE JACKSONVILLE TRANSPORTATION AUTHORITY FOR
12 THE "DOOR-TO-STORE PROGRAM" (THE "PROGRAM"), A
13 COMPONENT OF THE FULL-SERVICE GROCERY STORE
14 IMPROVEMENT PROGRAM ESTABLISHED UNDER
15 ORDINANCE 2019-812-E, AS INITIATED BY B.T. 21-
16 035; APPROVING AND AUTHORIZING THE MAYOR, OR
17 HIS DESIGNEE, AND THE CORPORATION SECRETARY TO
18 EXECUTE AND DELIVER THAT CERTAIN FUNDING
19 AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND
20 THE JACKSONVILLE TRANSPORTATION AUTHORITY TO
21 CONTINUE THE PROGRAM FOR AN ADDITIONAL ONE (1)
22 YEAR TERM; PROVIDING FOR CITY OVERSIGHT AND
23 PROGRAM ADMINISTRATION BY THE OFFICE OF
24 ECONOMIC DEVELOPMENT; PROVIDING FOR A REPORT
25 TO THE TRANSPORTATION, ENERGY AND UTILITIES
26 COMMITTEE; PROVIDING AN EFFECTIVE DATE.

28 **BE IT ORDAINED** by the Council of the City of Jacksonville:

29 **Section 1. Appropriation.** For the 2020-2021 fiscal year,
30 within the City's budget, there are hereby appropriated the

1 indicated sum(s) from the account(s) listed in subsection (a) to
2 the account(s) listed in subsection (b):

4 by this reference)

9 (c) Explanation of Appropriation:

10 The funding above is a transfer of funds from the
11 Northwest Jacksonville Economic Development Fund -
12 Contingency to the Northwest Jacksonville Economic
13 Development Fund - Subsidies and Contributions (the
14 "Trust Fund") to fund a grant to the Jacksonville
15 Transportation Authority (JTA) to enable the City to
16 continue operation of the Program for an additional one
17 (1) year term.

18 **Section 2. Purpose.** The purpose of the appropriation in
19 Section 1 is to fund the Program for an additional one (1) year
20 term. The Program provides complimentary on-demand transportation
21 services to local grocery stores for residents of the Northwest
22 Jacksonville Economic Development Area (the "Area") and
23 incentivizes the operation of new supermarkets and healthy food
24 programs within the Area. JTA will retain excess grant funds
25 appropriated by the City for the first year of the Program
26 authorized under Ordinance 2019-812-E as additional funding to
27 support the second year of the Program, up to a maximum carryover
28 amount of \$25,000.00. Any grant funds in excess of \$25,000.00
29 remaining from the first year of the Program shall be returned to
30 the City.

31 **Section 3. Approval and authorization.** There is hereby

1 approved, and the Mayor, or his designee, and the Corporation
2 Secretary are hereby authorized to execute and deliver, for and on
3 behalf of the City, that certain Funding Agreement between the City
4 of Jacksonville and the Jacksonville Transportation Authority,
5 attached hereto as **Exhibit 2** and incorporated herein by this
6 reference.

7 **Section 4. Oversight Department.** The Office of Economic
8 Development shall oversee and administer the Program described
9 herein.

10 **Section 5. Providing for a Report to the Transportation,**
11 **Energy and Utilities Committee.** JTA shall appear at the
12 Transportation, Energy and Utilities Committee and provide a status
13 update on the program within six (6) months of the effective date
14 of this ordinance.

15 **Section 6. Effective Date.** This ordinance shall become
16 effective upon signature by the Mayor or upon becoming effective
17 without the Mayor's signature.
