4 **ORDINANCE 2021-140**

5 AN ORDINANCE AUTHORIZING THE CITY TO ENTER INTO  
6 AN AMENDED AND RESTATED FUNDING AGREEMENT  
7 BETWEEN THE CITY OF JACKSONVILLE AND THE  
8 JACKSONVILLE TRANSPORTATION AUTHORITY ("JTA")  
9 TO EXPAND THE "DOOR-TO-STORE PROGRAM" APPROVED  
10 BY ORDINANCE 2021-46-E (THE "PROGRAM"), A  
11 COMPONENT OF THE FULL-SERVICE GROCERY STORE  
12 IMPROVEMENT PROGRAM ESTABLISHED UNDER ORDINANCE  
13 2019-812-E; PROVIDING FOR CITY OVERSIGHT AND  
14 PROGRAM ADMINISTRATION BY THE OFFICE OF ECONOMIC  
15 DEVELOPMENT; REQUESTING ONE CYCLE EMERGENCY  
16 PASSAGE; PROVIDING AN EFFECTIVE DATE.

18 **BE IT ORDAINED** by the Council of the City of Jacksonville:  
19

20 **Section 1. Approval and authorization for the Amended and**  
21 **Restated Funding Agreement.** There is hereby approved, and the  
22 Mayor, or his designee, and the Corporation Secretary are hereby  
23 authorized to execute and deliver, for and on behalf of the City,  
24 that certain Amended and Restated Funding Agreement between the City  
25 of Jacksonville and the Jacksonville Transportation Authority,  
26 attached hereto as **Exhibit 1** and incorporated herein by this  
27 reference. The purpose of the Amended and Restated agreement is to  
28 allow JTA to expand the "Door-To-Store" Program, as approved by  
29 Ordinance 2021-46-E, to provide for an additional drop off site and  
30 to expand the ride area.

31 **Section 2. Oversight Department.** The Office of Economic

1 Development shall oversee and administer the Program described  
2 herein.

3           **Section 3.           Requesting One Cycle Emergency Passage Pursuant**  
4 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this  
5 legislation is requested. The nature of the emergency is that  
6 expansion of the rider area was funded through Ordinance 2021-46-E  
7 and JTA is ready and willing to commence the new route service but  
8 amendment of the agreement must be approved by Council before JTA can  
9 begin the new routes.

10           **Section 4.           Effective Date.** This ordinance shall become  
11 effective upon signature by the Mayor or upon becoming effective  
12 without the Mayor's signature.
