ORDINANCE 2021-140

AN ORDINANCE AUTHORIZING THE CITY TO ENTER INTO AMENDED AND RESTATED FUNDING AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND THE JACKSONVILLE TRANSPORTATION AUTHORITY ("JTA") TO EXPAND THE "DOOR-TO-STORE PROGRAM" APPROVED BY ORDINANCE 2021-46-E (THE "PROGRAM"), A COMPONENT OF THE FULL-SERVICE GROCERY STORE IMPROVEMENT PROGRAM ESTABLISHED UNDER ORDINANCE 2019-812-E; PROVIDING FOR CITY OVERSIGHT AND PROGRAM ADMINISTRATION BY THE OFFICE OF ECONOMIC DEVELOPMENT; REQUESTING ONE CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Approval and authorization for the Amended and Section 1. Restated Funding Agreement. There is hereby approved, and the Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver, for and on behalf of the City, that certain Amended and Restated Funding Agreement between the City of Jacksonville and the Jacksonville Transportation Authority, attached hereto as **Exhibit 1** and incorporated herein by this reference. The purpose of the Amended and Restated agreement is to allow JTA to expand the "Door-To-Store" Program, as approved by Ordinance 2021-46-E, to provide for an additional drop off site and to expand the ride area.

Development shall oversee and administer the Program described herein.

Section 3. Requesting One Cycle Emergency Passage Pursuant to Council Rule 4.901 Emergency. One cycle emergency passage of this legislation is requested. The nature of the emergency is that expansion of the rider area was funded through Ordinance 2021-46-E and JTA is ready and willing to commence the new route service but amendment of the agreement must be approved by Council before JTA can begin the new routes.

Section 4. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
