9 GRANT FUNDING DISTRIBUTED BY UNITED WAY  
10 WORLDWIDE TO BE USED FOR EMERGENCY RENT,  
11 MORTGAGE AND UTILITY ASSISTANCE FOR ELIGIBLE  
12 DUVAL COUNTY VETERANS, AS INITIATED BY B.T. 21-  
13 051; PURPOSE OF APPROPRIATION; PROVIDING FOR  
14 OVERSIGHT BY THE MILITARY AFFAIRS AND VETERANS  
15 DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Appropriation.** For the 2020-2021 fiscal year,  
19 within the City's budget, there is hereby appropriated the indicated  
20 sum(s) from the account(s) listed in subsection (a) to the account(s)  
21 listed in subsection (b):

29 The funding above is an appropriation of \$13,500.00 in  
30 Emergency Food and Shelter Program Phase 38 grant funds  
31 from DHS/FEMA and distributed through United Way Worldwide

1 to be used to provide emergency mortgage, rent and utility  
2 assistance to Duval County veterans (the "EFSP Grant").

3 **Section 2. Purpose.** The purpose of the appropriation in  
4 Section 1 is to allocate EFSP Grant funds to the Military Affairs and  
5 Veterans Department to be used for emergency mortgage, rent and  
6 utility assistance for Duval County veterans in accordance with the  
7 EFSP Phase 38 - Budget attached hereto as **Exhibit 2** and incorporated  
8 herein by this reference. These funds will be utilized to supplement  
9 and extend existing resources available to local veterans and will  
10 not be used to substitute or reimburse ongoing programs and services.  
11 No City match is required.

12 **Section 3. Oversight Department.** The Office of Military  
13 Affairs and Veterans shall oversee administration of the EFSP Grant.

14 **Section 4. Effective Date.** This ordinance shall become  
15 effective upon signature by the Mayor or upon becoming effective  
16 without the Mayor's signature.
