ORDINANCE 2021-153

AN ORDINANCE APPROPRIATING \$6,011,963.00 IN EMERGENCY SOLUTIONS GRANT ("ESG") FUNDING FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT AUTHORIZED BY THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ("CARES") ACT TO BE USED TO PREVENT, PREPARE FOR, AND RESPOND TO CORONAVIRUS PANDEMIC ("COVID-19") PROVIDING AID AND ASSISTANCE TO INDIVIDUALS AND FAMILIES WHO ARE HOMELESS OR RECEIVING HOMELESSNESS PREVENTION ASSISTANCE, AND TO SUPPORT ADDITIONAL HOMELESS ASSISTANCE AND HOMELESSNESS PREVENTION ACTIVITIES TO MITIGATE THE IMPACTS OF COVID-19, AS INITIATED BY B.T. 21-045; INVOKING THE EXCEPTION OF SECTION 126.107(G) (EXEMPTIONS), PART 1 (GENERAL REGULATIONS), CHAPTER 126, (PROCUREMENT CODE), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH CHANGING HOMELESSNESS, INC.; APPROVING AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY AN AGREEMENT WITH CHANGING HOMELESSNESS, INC. FOR THE PROVISION OF SERVICES DESCRIBED IN THIS ORDINANCE; PROVIDING FOR OVERSIGHT BY THEHOUSING AND COMMUNITY DEVELOPMENT DIVISION, NEIGHBORHOODS DEPARTMENT; PROVIDING FOR COMPLIANCE WITH ALL CARES ACT GRANT FUNDING REQUIREMENTS AND OTHER

1 REQUIREMENTS AS PROVIDED BY LAW; REQUESTING 2 EMERGENCY PASSAGE UPON INTRODUCTION; PROVIDING 3 AN EFFECTIVE DATE. 4 5 BE IT ORDAINED by the Council of the City of Jacksonville: Appropriation. For the 2020-2021 fiscal year, 6 Section 1. 7 within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) 8 9 listed in subsection (b): 10 (B.T. 21-045 attached hereto as **Exhibit 1** and incorporated herein by this reference) 11 (a) Appropriated from: 12 See B.T. 21-045 \$6,011,963.00 13 (b) Appropriated to: 14 See B.T. 21-045 \$6,011,963.00 15 (c) Explanation of Appropriation: 16 The funding above is an appropriation of Emergency 17 Solutions Grant funds in the amount of \$6,011,963.00 from 18 the U.S. Department of Housing and Urban Development 19 20 ("HUD") authorized by the CARES Act ("ESG-CV Funds"), of 21 which \$5,715,000.00 will be disbursed to Changing 22 Homelessness, Inc. for the provision of services described in this ordinance, and \$296,963.00 will be retained by the 23 24 City to cover administrative costs incurred by the Housing 25 Community Development Division and for 26 administration.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide aid and assistance to prevent, prepare for, and respond to COVID-19 among individuals and families who are

homeless or receiving homelessness assistance, and to support additional homeless assistance and homelessness prevention activities to mitigate the impacts of COVID-19. The ESG-CV Funds will be used to provide rapid rehousing services, including acquisition of noncongregate shelter space (hotel rooms), and COVID-19 testing services for eligible recipients and for acquisition of shelter equipment and supplies. These funds may also be used to cover or reimburse allowable costs incurred by the City before the award of funding from HUD, including allowable costs incurred prior to the signing of the CARES Act. A copy of the HUD ESG-CV Funds award letter is attached hereto as **Exhibit 2** and incorporated herein by this reference.

Section 3. Invoking the exception to Section 126.107(g), Ordinance Code. The City is hereby authorized to procure the use of the professional services of Changing Homelessness, Inc. ("CH, Inc.") to provide Emergency Solutions Grant Coronavirus assistance services as more particularly described in Exhibit 3, attached hereto and incorporated herein by this reference (the "ESG-CV Services"). Pursuant to Section 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance Code, such procurement is exempted from competitive solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation that appropriates the same. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect.

Section 4. Authorizations. The Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City an agreement with Changing Homelessness, Inc. in an amount not to exceed \$5,715,000.00, subject to the Scope of Work and Program Budget more particularly described in Exhibit 3,

and all other contracts and documents, including extensions, renewals and amendments to the agreement, and otherwise take all action necessary to effectuate the intent of this ordinance, subject to appropriate legal review and approval by the General Counsel, or his or her designee, and the City's Risk Management Division for appropriate insurance and indemnification requirements in accordance with Section 128.601, Ordinance Code.

Section 5. Oversight department. The Housing and Community Development Division, Neighborhoods Department shall provide oversight of expenditure of the ESG-CV Funds and the ESG-CV Services to be provided by CH, Inc.

Section 6. Compliance with applicable CARES Act grant requirements. CH, Inc. will comply with all CARES Act grant requirements in providing the ESG-CV Services and all other requirements provided by law including, but not limited to, the audit requirements attached hereto as **Exhibit 4** and incorporated herein by this reference.

Section 7. Requesting emergency passage upon introduction pursuant to Council Rule 4.901. Emergency passage of this legislation is requested upon introduction. The nature of the emergency is that the negative economic impacts of COVID-19 are ongoing and immediate assistance is needed to ensure eligible individuals and families have access to shelter, COVID-19 testing, and other homelessness prevention services.

Section 8. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
