OED is proposing to submit legislation authorizing the City to enter into a redevelopment agreement with Theotokos Holdings, LLC to redevelop a vacant office building located at 7820 Arlington Expressway. The proposed building will be converted to 118 market rate rental apartments to serve the Regency Square / Arlington market area, a Level II Economically Distressed Area. The building was originally constructed in 1975 along with two other office buildings to serve as the headquarters for Westinghouse's Offshore Power Systems. Presently all three office buildings are vacant and deteriorating. The last tenant in the subject building was the FBI who vacated in 2009 and relocated to <u>Gate Parkway.</u>

The private capital investment associated with this redevelopment project is \$14,545,000.

The public investment proposed is a Recaptured Enhanced Value (REV) Grant at the level of 75% of the incremental net increase in the ad valorem portion of the real and tangible property taxes resulting from the construction costs to convert the 95,000 SF former office building to 118 rental apartments. The term of the proposed REV Grant is ten (10) years. The estimated value of the REV Grant over the ten (10) year period is \$820,000.

## The City of Jacksonville proposes to provide:

<u>A REV grant based on 75 percent of the increase in ad valorem and tangible personal property taxes</u> generated at the project site, for 10 years up to a maximum of \$820,000; provided the private capital investment is not less than \$11 million for demolition and construction of the apartment units no later than December 31, 2023. In the event the overall investment is less than \$11 million the REV Grant will be adjusted to 50%. If the overall investment falls below \$9 million, the grant will be terminated. The project has a positive Return on Investment for the City of Jacksonville.

The total amount of City incentives would be up to \$820,000.
