2 Section 2. **Purpose.** The purpose of the appropriation in Section 1 is to provide additional funding for expenses arising 3 from ongoing COVID-19 response efforts administered by the Florida 4 Department of Health in Duval County ("DOH"). Response efforts for 5 which these funds may be expended include, but are not limited to, 6 7 interviewing, evaluating and monitoring clients on matters related to COVID-19, providing education and guidance on COVID-19 related 8 9 issues, and counseling on isolation/quarantine parameters. The 10 funds may also be used to support ongoing COVID-19 vaccination planning and distribution efforts and other health-related needs. 11

12 Section 3. Reporting Requirements. The DOH shall submit 13 a detailed summary of expenditures of Funds, to include invoices, 14 to the Director of the Finance and Administration Department on a 15 quarterly basis. A final detailed report shall be due after all 16 funds have been expended.

Requesting emergency passage upon introduction 17 Section 4. 18 pursuant to Council Rule 4.901. Emergency passage of this 19 legislation is requested upon introduction. The nature of the 20 emergency is that the negative impacts of COVID-19 are ongoing and 21 these funds will allow the DOH to continue providing uninterrupted 22 COVID-19 response services to the community.

23 Section 5. Effective Date. This ordinance shall become 24 effective upon signature by the Mayor or upon becoming effective 25 without the Mayor's signature.
