5 AN ORDINANCE CONFIRMING THE MAYOR'S APPOINTMENT
6 OF CHRISTOPHER R. BUTLER, A ST. JOHNS COUNTY
7 RESIDENT WITH SUBSTANTIAL BUSINESS INTEREST IN
8 DUVAL COUNTY, TO THE BETTER JACKSONVILLE PLAN
9 FINANCIAL ADMINISTRATION COMMITTEE, AS A PRIVATE
10 CITIZEN, REPLACING PAUL SLEIMAN, PURSUANT TO
11 SECTION 761.107, *ORDINANCE CODE*, FOR A FIRST
12 FULL TERM TO EXPIRE MARCH 31, 2026; PROVIDING
13 FOR A NON-RESIDENT OF DUVAL COUNTY WITH
14 SUBSTANTIAL ECONOMIC BUSINESS INTEREST TO BE
15 SEATED ON THE BETTER JACKSONVILLE PLAN FINANCIAL
16 ADMINISTRATION COMMITTEE; PROVIDING AN
17 EFFECTIVE DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appointment.** The Council hereby confirms the
21 Mayor's appointment of Christopher R. Butler, a St. Johns County
22 resident with substantial business interest in Duval County, to the
23 Better Jacksonville Plan Financial Administration Committee, as a
24 private citizen, replacing Paul Sleiman, pursuant to Section 761.107,
25 *Ordinance Code*, for a first full term to expire March 31, 2026.

26 **Section 2. A Non-Resident of Duval County with substantial**
27 **economic business interests in Duval County.** Section 50.102 (Members
28 of boards and commissions), *Ordinance Code*, requires Board and
29 Commission members be either a Duval County resident or individuals
30 with substantial economic business or philanthropic interests in
31 Duval County. Mr. Butler has substantial business interests in Duval

1 County. Mr. Butler serves as the Managing Partner of DF Capital
2 Management, an affiliate of Dream Finders Homes, located at 14701
3 Philips Hwy, Jacksonville, FL 32256.

4 **Section 3. Effective Date.** This ordinance shall become
5 effective upon signature by the Mayor or upon becoming effective
6 without the Mayor's signature.
