pursuant to Section 147(f) of the Internal Revenue Code of 1986, as amended, of a public hearing by the Jacksonville Housing Finance Authority (the "Authority") to be held on February 9, 2021 at 10a.m., or as soon thereafter as possible. The purpose of the public hearing is to receive comments and hear discussion concerning the issuance by the Authority of its Multifamily Housing Revenue Bonds (Beachwood Apartments), Series 2021, in an aggregate face amount of not to exceed \$26,500,000 (the "Bonds"). The proceeds of the Bonds will be loaned to Beachwood Preservation LP or its permitted successors and assigns (the "Company"), and used for the purpose of financing all or a portion of the costs related to the acquisition and rehabilitation of a multifamily residential housing facility for persons or families of low, middle or moderate income located at 2901 Beachwood Blvd, Jacksonville, Duval County, Florida, 32246, consisting of approxi-mately 148 units to be commonly known as Beachwood Apart-ments (the "Project"). Beachwood Preservation LP, or its affiliate is expected to be the owner and operator of the Project.
All interested persons are invit-

ed to attend said hearing and, either personally or through their representatives, present oral or written comments and discussion concerning the proposed issu-ance of the Bonds for the purposes described in the preceding paragraph and the nature and location of the Project. Written comments may be submitted to the Jacksonville Housing Finance Authority, 214 N. Hogan Street, 7th Floor, Jacksonville, Florida, 32202. Should any person decide to appeal any decision made by the Authority at this hearing, or by the Council of the City of Jacksonville (the "City") with respect to the approval of the issuance of the Bonds for the purposes described in the preceding paragraph, he or she will need a record of the proceedings, and he or she may need to insure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based. Comments made at the hearing are for the consideration of the Authority or the City and will not bind the Authority or
