AN ORDINANCE APPROPRIATING \$358,000 (\$195,000 RETURNED TOURIST DEVELOPMENT OF COUNCIL TOURIST OPERATIONS DOLLARS, \$109,000 OF DEVELOPMENT COUNCIL CONVENTION SALES BUDGET DOLLARS, AND \$54,000 OF TOURIST DEVELOPMENT COUNCIL TOURIST BUREAU/DESTINATION SERVICES BUDGET DOLLARS) TO THE TOURIST DEVELOPMENT COUNCIL MARKETING ACTIVITY ACCOUNT; PURPOSE; THE TOURIST DEVELOPMENT COUNCIL AMENDING FISCAL YEAR 2020-2021 BUDGET (REVISED SCHEDULE W) APPROVED BY ORDINANCE 2020-504-E (CITY'S ANNUAL BUDGET), TO RETURN FUNDS CONSERVED DUE TO COVID-19 RESTRICTIONS IN FISCAL YEAR 2019-2020 TO MARKETING USES; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Duval County Tourist Development Council (the "Tourist Development Council" or "TDC"), pursuant to Chapter 70, Ordinance Code, administers the Tourist Development Plan set forth in Chapter 666, Ordinance Code; and
