AN ORDINANCE APPROPRIATING \$153,000.00 FROM THE SPECIAL LAW ENFORCEMENT TRUST FUND (THE "FUND") FOR DONATIONS TO BIG BROTHERS BIG SISTERS OF NORTHEAST FLORIDA, INC. (\$15,000.00), DOWNTOWN VISION ALLIANCE, INC. (\$10,000.00), FLORIDA SHERIFFS YOUTH RANCHES, INC. (\$20,000.00), OPERATION SAVE OUR SONS, INC. (\$40,000.00), AND THE ORANGE COUNTY SHERIFF'S OFFICE, NATIONAL CONFERENCE PREVENTING CRIME IN THE BLACK COMMUNITY (\$3,000.00) IN ACCORDANCE WITH SECTION 932.7055(5), FLORIDA STATUTES, TO SUPPORT SCHOOL RESOURCE OFFICER, CRIME PREVENTION, SAFE NEIGHBORHOOD, AND DRUG ABUSE EDUCATION AND PREVENTION PROGRAMS, APPROPRIATING \$65,000.00 FROM THE FUND TO REIMBURSE THE FUND FOR FORFEITURE-RELATED GENERAL EXPENDITURES IN ACCORDANCE WITH SECTION 932.7055(4)(C), FLORIDA STATUTES, AND REALLOCATING A TOTAL OF \$82,610.40 IN PRIOR YEAR RESIDUAL BALANCES, AS INITIATED BY B.T. 21-063; PURPOSE OF APPROPRIATION; APPROVING AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY, THE MISCELLANEOUS APPROPRIATIONS AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND BIG BROTHERS BIG

SISTERS OF NORTHEAST FLORIDA, INC., THE MISCELLANEOUS APPROPRIATIONS AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND DOWNTOWN VISION INC., THE ALLIANCE, MISCELLANEOUS APPROPRIATIONS AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND FLORIDA SHERIFFS YOUTH INC., AND \mathtt{THE} MISCELLANEOUS RANCHES, APPROPRIATIONS AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND OPERATION SAVE OUR INC.; PROVIDING FOR CITY OVERSIGHT BY JACKSONVILLE SHERIFF'S OFFICE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2020-2021 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide donations to the following organizations, in the stated amounts: Big Brothers Big Sisters of Northeast Florida, Inc. (\$15,000.00), Downtown Vision Alliance, (\$10,000.00), Florida Sheriffs Youth Ranches, Inc. (\$20,000.00), Operation Save Our Sons, Inc. (\$40,000.00), and Orange County Sheriff's Office, National Conference on Preventing Crime in the Black Community (\$3,000.00). This allocation supports school resource officer, crime prevention, safe neighborhood, and drug abuse education and prevention program services to the citizens of the City of Jacksonville, Duval County, Florida. A Certification from the Jacksonville Sheriff's Office that the subject appropriation from the Special Law Enforcement Trust Fund complies with Section 932.7055, Florida Statutes, is attached hereto as Exhibit 2 and incorporated herein by this reference.

In addition to the above, this appropriation includes a transfer of \$65,000.00 from the Fund to the General Fund as a reimbursement for forfeiture-related expenditures in accordance with Section 932.7055(4)(c), Florida Statutes, and a realloaction of \$82,610.40 in residual balances from prior year appropriations.

Section 3. Approval and Authorization. There is hereby approved, and the Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City, the Miscellaneous Appropriations Agreement between the City of Jacksonville and Big Brothers Big Sisters of Northeast Florida, Inc., the Miscellaneous Appropriations Agreement between

the City of Jacksonville and Downtown Vision Alliance, Inc., the Appropriations Agreement between the Miscellaneous City Jacksonville and the Florida Sheriffs Youth Ranches, Inc., and the Miscelllaneous Appropriations Agreement between the City of Jacksonville and Operation Save Our Sons, Inc., in substantially the same forms as have been placed **On File** with the Office of Legislative Services.
