AN ORDINANCE APPROPRIATING A \$470,000.00 GRANT FROM THE STATE OF FLORIDA DEPARTMENT OF LAW ENFORCEMENT TO FUND EXPANSION OF THE CITY OF JACKSONVILLE'S CURE VIOLENCE INITIATIVE, AS INITIATED BY B.T. 21-041; PURPOSE OF THE APPROPRIATION; AUTHORIZING THE CITY TO ENTER INTO AN AMENDMENT TO THE AGREEMENT WITH FAMILY FOUNDATIONS OF NORTHEAST FLORIDA, INC.; APPROVING, AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER AN AGREEMENT WITH THE POTTER'S HOUSE CHRISTIAN FELLOWSHIP, INC.; APPROVING, AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE CORPORATION SECRETARY, TO EXECUTE AND DELIVER AN AGREEMENT WITH BUILDERS OF THE FAITH CHRISTIAN CENTER AND DAY CARE INC.; APPROVING, AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE CORPORATION SECRETARY, EXECUTE AND DELIVER AN AGREEMENT JUSTICE & SECURITY STRATEGIES, LLC; INVOKING SECTION EXCEPTION OF 126.107(G) (EXEMPTIONS), PART 1 (GENERAL REGULATIONS, CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, TO DIRECT CONTRACT WITH FAMILY FOUNDATIONS OF NORTHEAST FLORIDA, INC., THE POTTER'S HOUSE CHRISTIAN FELLOWSHIP, INC.,

BUILDERS OF THE FAITH CHRISTIAN CENTER AND DAY CARE INC., AND JUSTICE & SECURITY STRATEGIES, LLC, FOR THE PROVISION OF SERVICES RELATED TO THE EXPANDED CURE VIOLENCE INITIATIVE AS MORE PARTICULARLY DESCRIBED HEREIN; PROVIDING FOR OVERSIGHT BY THE OFFICE OF GRANT AND CONTRACT COMPLIANCE; REQUESTING ONE CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

WHEREAS, at the beginning of the State of Florida's fiscal year 2020-2021, the State of Florida Department of Law Enforcement ("FDLE") appropriated to the City of Jacksonville a single, non-recurring grant in the amount of \$470,000.00 for expansion of the City's Cure Violence initiative to a third site; and

WHEREAS, FDLE subsequently provided the grant award and conditions (the "Grant") to the City in December 2020; and

WHEREAS, since receipt of the Grant, the Office of Grant and Contract Compliance has worked closely with the Jacksonville Sheriff's Office to define the service boundary for the third Cure Violence site and has identified various service providers who are appropriately located within said boundary and/or who have the requisite framework in place to immediately begin providing services in support of the expanded Cure Violence initiative; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2020-2021 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation:

The funding above represents a grant in the amount of \$470,000.00 from the State of Florida Department of Law Enforcement, Office of Criminal Justice Grants Program, to establish a third Cure Violence operating site in support of the local Cure Violence initiative. No local match is required.

Purpose. The purpose of the appropriation in Section 2. Section 1 is to fund expansion of the City's Cure Violence initiative by establishing a third Cure Violence operating site to administer implementation of the Cure Violence Public Health Violence Reduction Model (the "Program"). This Program was established to reduce and prevent shootings and killings in Jacksonville. Grant funds must be expended in accordance with the terms and conditions of the FDLE Grant Award (Grant Number 2021-SFA-GAA-15-4D-002) and the corresponding Fiscal Year 2020-2021 State Financial Assistance Standard Conditions, attached hereto as Exhibit 2 and incorporated herein by this reference. will be used to procure contractual services particularly described in this Ordinance to support expansion of the Program for the Grant period commencing July 1, 2020 through June 30, 2021 as follows: (1) \$30,000.00 to Family Foundations of Northeast Florida, Inc.; (2) \$360,000.00 to The Potter's House Christian Fellowship, Inc.; (3) \$50,000.00 to Builders of the Faith Christian Center and Day Care Inc.; and (4) \$30,000.00 to Justice & Security Solutions, LLC. All Cure Violence Program activities shall be completed in strict compliance with federal, state and

local rules and regulations.

Section 3. the City Authorizing to enter into an amendment to the agreement with Family Foundations of Northeast The City is hereby authorized to enter into an Florida, Inc. amendment to the FY 2020-2021 Cure Violence Services Contract with Family Foundations of Northeast Florida, Inc., originally approved and authorized in Ordinance 2020-504-E, for the provision services in support of the expanded Cure Violence Program described in Exhibit 3, attached hereto and incorporated herein by this reference, and to increase the maximum indebtedness of said contract by \$30,000.00.

Section 4. Approval and authorization to execute an agreement between the City and The Potter's House Christian Fellowship, Inc. ("Potter's House"). The Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver a Cure Violence Services Contract between the City of Jacksonville and Potter's House in a not to exceed amount of \$360,000.00, for management and oversight of the third Cure Violence Program site as more particularly described in Exhibit 4, attached hereto and incorporated herein by this reference. agreement may include such additions, deletions and changes as may be reasonable, necessary and incidental for carrying out purposes thereof, as may be acceptable to the Mayor, designee, with such inclusion and acceptance being evidenced by execution of the Agreement by the Mayor, or his designee; provided however, no modifications to the agreement may increase the financial obligations or liability of the City to an amount in excess of the amount stated in the agreement or decrease the duties and obligations of Potter's House, and any such modifications shall be technical only and shall be subject to appropriate legal review and approval by the Office of General Counsel and the Office of

Risk Management for appropriate insurance and indemnification terms. For the purposes of this Ordinance, the term "technical changes" is defined as those changes having no financial impact to the City and any other non-substantive changes that do not substantively increase the duties and responsibilities of the City under the provisions of the agreement.

Section 5. Approval and authorization to execute an agreement between the City and Builders of the Faith Christian Center and Day Care Inc. ("Builders of the Faith"). The Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver a Cure Violence Services Contract between the City of Jacksonville and Builders of the Faith in a not to exceed amount of \$50,000.00, for the provision of services in support of Potter's House and the expanded Cure Violence Program as described in **Exhibit 5**, attached hereto and incorporated herein by The agreement may include such additions, this reference. deletions and changes as may be reasonable, necessary incidental for carrying out the purposes thereof, as may be acceptable to the Mayor, or his designee, with such inclusion and acceptance being evidenced by execution of the agreement by the Mayor, or his designee; provided however, no modifications to the Agreement may increase the financial obligations or liability of the City to an amount in excess of the amount stated in the agreement or decrease the duties and obligations of Builders of the Faith, and any such modifications shall be technical only and shall be subject to appropriate legal review and approval by the Office of General Counsel and the Office of Risk Management appropriate insurance and indemnification terms. For the purposes of this Ordinance, the term "technical changes" is defined as those changes having no financial impact to the City and any other nonsubstantive changes that do not substantively increase the duties

and responsibilities of the City under the provisions of the agreement.

Section 6. Approval and authorization to agreement between the City and Justice & Security Solutions, LLC ("JSS"). The Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver a Cure Violence Services Contract between the City of Jacksonville and JSS in a not to exceed amount of \$30,000.00, for the provision of data analytics services in support of the expanded Cure Violence Program as described in Exhibit 6, attached hereto and incorporated herein by agreement may include such additions, this reference. The deletions and changes may be reasonable, necessary as incidental for carrying out the purposes thereof, as may be acceptable to the Mayor, or his designee, with such inclusion and acceptance being evidenced by execution of the agreement by the Mayor, or his designee; provided however, no modifications to the Agreement may increase the financial obligations or liability of the City to an amount in excess of the amount stated in the agreement or decrease the duties and obligations of JSS, and any such modifications shall be technical only and shall be subject to appropriate legal review and approval by the Office of General Counsel and the Office of Risk Management for appropriate insurance and indemnification terms. For the purposes of this Ordinance, the term "technical changes" is defined as those changes having no financial impact to the City and any other non-substantive changes that do not substantively increase the duties and responsibilities of the City under the provisions of the agreement.

Section 7. Invoking the exception to Section 126.107(g), Ordinance Code. The City is hereby authorized to enter direct agreements or amendments to agreements, as authorized herein, with Family Foundations of Northeast Florida, Inc., The Potter's House

Christian Fellowship, Inc., Builders of the Faith Christian Center and Day Care Inc., and Justice & Security Solutions, LLC, for the purposes of providing services to the expanded Cure Violence Program. Pursuant to Section 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance Code, such procurement is exempted from competitive solicitation because the supplies or services are to be provided by those the authorizing legislation specifically described in appropriates the same. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect. The failure of any entity identified herein to enter into the applicable agreement or amendment to agreement with the City shall render such entity ineligible to receive the Grant funds authorized hereby.

Section 8. Expenditure of Public Funds on Food, pursuant to Section 106.203(b), Ordinance Code. The Program is authorized to expend funds (up to 5% of the total Grant in the aggregate) on food and beverage. The purpose of the Program is outreach to the community to effectuate change with the goal of reducing violence. The food will be one source of interacting with the community at large to implement the Program.

Section 9. Oversight Department. The Office of Grant and Contract Compliance shall oversee administration of the Grant and Program described herein.

Section 10. Requesting One Cycle Emergency Passage

Pursuant to Council Rule 4.901 Emergency. One cycle emergency

passage of this legislation is requested. The nature of the emergency is that the Grant period ends June 30, 2021.

Section 11. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
