7 **ORDINANCE 2021-207-E**

8 AN ORDINANCE APPROVING THE TARPON COVE
9 DEPENDENT SPECIAL DISTRICT PROPOSED FISCAL
10 YEAR 2021/2022 BUDGET, PER ORDINANCE 2017-154-
11 E AND SECTION 189.02, *FLORIDA STATUTES*;
12 RATIFYING AND APPROVING A REVISED FISCAL YEAR
13 BUDGET FOR 2020/2021 FOR TARPON COVE DEPENDENT
14 DISTRICT; PROVIDING AN EFFECTIVE DATE.

16 **WHEREAS**, the City of Jacksonville established the Tarpon Cove
17 Dependent Special District (the "District"), per Ordinance 2017-
18 154-E and section 189.02, *Florida Statutes*, a dependent special
19 district for the purpose of dredging the Tarpon Cove canal system;
20 and

21 **WHEREAS**, in order for the District to qualify as a dependent
22 special district per section 189.02, *Florida Statutes*, the City, in
23 Ordinance 2017-154-E, required the District to submit its proposed
24 budget to the City Council every year by April 1st; and

25 **WHEREAS**, the District has submitted the proposed Fiscal Year
26 2021/2022 budget to the City Council prior to April 1st and is
27 seeking approval of the budget by the City Council; and

28 **WHEREAS**, the City Council finds that the Tarpon Cove Dependent
29 Special District proposed Fiscal Year 2021/2022 budget, attached
30 hereto as **Exhibit 1**, should be approved; now therefore

1 **BE IT ORDAINED** by the Council of the City of Jacksonville:

2 **Section 1. Approval of Tarpon Cove Dependent Special**
3 **District Proposed Fiscal Year 2021/2022 Budget.** The Tarpon Cove
4 Dependent Special District proposed Fiscal Year 2021/2022 budget,
5 attached hereto as **Exhibit 1**, is hereby approved.

6 **Section 2. Amendment to Ordinance 2020-215-E; Ratification**
7 **and Approval of Tarpon Cove Dependent Special District Revised**
8 **Fiscal Year 2020/2021 Budget.** The Tarpon Cove Dependent Special
9 District proposed Fiscal Year 2020/2021 budget was approved by
10 Ordinance 2020-215-E. Thereafter, the Tarpon Cove Dependent
11 Special District revised its Fiscal Year 2020/2021 budget to
12 include loan proceeds, as evidenced by **Exhibit 2**, attached hereto.
13 The Tarpon Cove Dependent Special District has submitted the
14 revised Fiscal Year 2020/2021 budget to the Council for review as
15 required by its Charter. The Council hereby ratifies and approves
16 the Revised Fiscal 2020/2021 budget attached hereto as **Exhibit 2**.

17 **Section 3. Effective Date.** This ordinance shall become
18 effective upon signature by the Mayor or upon becoming effective
19 without the Mayor's signature.
