ORDINANCE 2021-256-E

AN ORDINANCE APPROPRIATING \$50,000 FROM THE SOCIAL JUSTICE AND COMMUNITY INVESTMENT SPECIAL COMMITTEE CONTINGENCY FOR THE 2021 FLORIDA BLACK EXPO SPRING EMPOWERMENT SUMMIT; APPROVING, AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND CORPORATION SECRETARY TO EXECUTE AND DELIVER, AN AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND THE POLLOCK GROUP, LLC; INVOKING THE EXCEPTION IN SECTION 126.107(G), ORDINANCE CODE, TO ALLOW DIRECT CONTRACT WITH THE POLLOCK GROUP, LLC TO PROVIDE THE SERVICES FOR THE 2021 FLORIDA BLACK EXPO SPRING EMPOWERMENT SUMMIT; WAIVING SECTION 110.112 (ADVANCE OF CITY FUNDS; PROHIBITION AGAINST), PART 1 (THE CITY TREASURY), CHAPTER 110 (CITY TREASURY), ORDINANCE CODE, TO ALLOW FOR A PARTIAL ADVANCE PAYMENT BY THE CITY; PROVIDING FOR OVERSIGHT BY THE OFFICE OF GRANTS AND CONTRACT COMPLIANCE; REQUESTING ONE CYCLE EMERGENY PASSAGE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2020-2021 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to

(c) Explanation of Appropriation - The funding above is being appropriated from the Social Justice and Community Investment Special Committee Contingency to the Office of Grants and Contract Compliance to provide funding to the Pollock Group, LLC for the 2021 Florida Black Expo Spring Empowerment Summit.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding to The Pollock Group, LLC, for the 2021 Florida Black Expo Spring Empowerment Summit, including four vendor booths for the City of Jacksonville at no cost, as more fully described in Exhibit 2 attached hereto.

There is hereby approved, and the Mayor, or his designee, and Corporation Secretary are hereby authorized to execute and deliver, the Funding Agreement between the City of Jacksonville and The Pollock Group, LLC, in substantially the form as attached hereto as Exhibit 3, and incorporated herein by this reference (the "Agreement"). The Agreement may include such additions, deletions and changes as may be reasonable, necessary and incidental for carrying out the purposes thereof, as may be acceptable to the Mayor, or his designee, with such inclusion and acceptance being evidenced by execution of the Agreement by the Mayor, or his designee; provided however, no modification to the Agreement may increase the financial obligations or liability of the City to an

amount in excess of the amount stated in the Agreement or decrease the duties and obligations of The Pollock Group, LLC, and any such modification shall be technical only and shall be subject to appropriate legal review and approval by the Office of General Counsel. For the purposes of this Ordinance, the term "technical changes" is defined as those changes having no financial impact to the City and any other non-substantive changes that do not substantively increase the duties and responsibilities of the City under the provisions of the Agreement.

Section 4. Invoking the exception to Section 126.107(g), Ordinance Code. The City is hereby authorized to procure the use of the professional services of The Pollock Group, LLC, to provide services for the 2021 Florida Black Expo Spring Empowerment Summit. Pursuant to Section 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance Code, such procurement is exempted from competitive solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation that appropriates the same. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect.

Section 5. Waiving Section 110.112, Ordinance Code. Section 110.112 (Advance of City funds; prohibition against), Part 1 (The City Treasury), Chapter 110 (City Treasury), Ordinance Code, is hereby waived to allow for a partial advance payment as described in the Agreement.

Section 6. Oversight. The Mayor is requested to appoint the Office of Grants and Contract Compliance to oversee the project in Section 2 above and to ensure compliance with all other appropriate laws.

Section 7. Requesting One Cycle Emergency Passage

Pursuant to Council Rule 4.901 Emergency. One cycle emergency

passage of this legislation is requested. The nature of the emergency is that the 2021 Florida Black Expo Spring Empowerment Summit will take place May 21-22, 2021.
