AN ORDINANCE APPROPRIATING \$100,974 FROM THE SOCIAL JUSTICE AND COMMUNITY INVESTMENT SPECIAL COMMITTEE CONTINGENCY FOR THE 5000 ROLE MODELS OF EXCELLENCE PROJECT; AMENDING THIRD REVISED SCHEDULE M TO ORDINANCE 2020-511-E; APPROVING, AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND CORPORATION SECRETARY TO EXECUTE AND DELIVER, AN AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND JACKSONVILLE PUBLIC EDUCATION FUND, INC. ("JPEF"); INVOKING THE EXCEPTION IN SECTION 126.107(G), ORDINANCE CODE, TO ALLOW DIRECT CONTRACT WITH JACKSONVILLE PUBLIC EDUCATION FUND, INC. TO PROVIDE THE SERVICES FOR THE 5000 ROLE MODELS OF EXCELLENCE PROJECT; WAIVING THE REQUIREMENTS OF CHAPTER 77 (KIDS HOPE ALLIANCE), SECTION 77.111(A) (PROVIDER CONTRACTS), ORDINANCE CODE, TO EXEMPT THE SERVICES TO BE PROVIDED BY JACKSONVILLE PUBLIC EDUCATION FUND, INC. FROM COMPETITIVE PROCUREMENT; WAIVING SECTION 110.112 (ADVANCE OF CITY FUNDS; PROHIBITION AGAINST), PART 1 (THE CITY TREASURY), CHAPTER 110 (CITY TREASURY), ORDINANCE CODE, TO ALLOW FOR A PARTIAL ADVANCE PAYMENT BY THE CITY; PROVIDING FOR OVERSIGHT BY THE KIDS HOPE ALLIANCE; PROVIDING AN EFFECTIVE DATE.

 BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2020-2021 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation - The funding above is being appropriated from the Social Justice and Community Investment Special Committee Contingency and to be utilized by the Jacksonville Public Education Fund, Inc. for the 5000 Role Models of Excellence project.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding for the 5000 Role Models of Excellence project, as more fully described in Exhibit 2 attached hereto. The 5000 Role Models of Excellence project seeks to provide a sense of hope to young minority male students by offering positive visions of success to serve as a blueprint for emulation through mentorship and exposure. The project is committed to connecting students of promise to positive adult role models whose successes can inspire them to achieve.

Section 3. Amending Third Revised Schedule M to Ordinance 2020-511-E. There is hereby amended for the fiscal year 2020-2021 budget for the Kids Hope Alliance by substituting in the place of Third Revised Schedule M, approved by Ordinance 2020-511-E, the Fourth Revised Schedule M, attached hereto as Exhibit 3 and

incorporated herein by this reference. The Fourth Revised Schedule M will reflect additional transfers and funds appropriated herein.

Section 4. Agreement approved and execution authorized. There is hereby approved, and the Mayor, or his designee, and Corporation Secretary are hereby authorized to execute and deliver, the Funding Agreement between the City of Jacksonville Jacksonville Public Education Fund, Inc., in substantially the form as attached hereto as Exhibit 4, and incorporated herein by this reference (the "Agreement"). The Agreement may include such additions, deletions and changes as may be reasonable, necessary and incidental for carrying out the purposes thereof, as may be acceptable to the Mayor, or his designee, with such inclusion and acceptance being evidenced by execution of the Agreement by the Mayor, or his designee; provided however, no modification to the Agreement may increase the financial obligations or liability of the City to an amount in excess of the amount stated in the Agreement or decrease the duties and obligations of Jacksonville Public Education Fund, Inc., and any such modification shall be technical only and shall be subject to appropriate legal review and approval by the Office of General Counsel. For the purposes of this Ordinance, the term "technical changes" is defined as those changes having no financial impact to the City and any other nonsubstantive changes that do not substantively increase the duties and responsibilities of the City under the provisions of the Agreement.

Section 5. Invoking the exception to Section 126.107(g), Ordinance Code. The City is hereby authorized to procure the use of the professional services of Jacksonville Public Education Fund, Inc., to provide services for the 5000 Role Models of Excellence project. Pursuant to Section 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance

Code, such procurement is exempted from competitive solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation that appropriates the same. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect.

Waiving the requirements of Chapter 77 (Kids Section 6. Hope Alliance), Section 77.111(a) (Provider Contracts), Ordinance Code. The City hereby waives the requirements of Chapter 77 (Kids Hope Alliance), Section 77.111(a) (Provider Contracts), Ordinance Code, with respect to the contract approved and authorized under Section 3 of this Ordinance. Section 77.111(a) requires contracts for children's services to be competitively procured by KHA via an evaluated bid process. This waiver is needed because Jacksonville Public Education Fund, Inc. is the sole provider for the 5000 Role Models of Excellence project in Duval County.

Section 7. Waiving Section 110.112, Ordinance Code. Section 110.112 (Advance of City funds; prohibition against), Part 1 (The City Treasury), Chapter 110 (City Treasury), Ordinance Code, is hereby waived to allow for a partial advance payment as described in the Agreements.

Section 8. Oversight. KHA will oversee the project and services described in Section 2 above and will ensure compliance with all other appropriate laws.

Section 9. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
