5 AN ORDINANCE APPROVING AND AUTHORIZING THE  
6 MAYOR, OR HIS DESIGNEE, AND CORPORATION  
7 SECRETARY TO EXECUTE AND DELIVER AN AMENDMENT  
8 TWO TO ECONOMIC DEVELOPMENT AGREEMENT BETWEEN  
9 THE CITY OF JACKSONVILLE ("CITY") AND EAGLE  
10 LNG PARTNERS, LLC ("COMPANY") ("AMENDMENT 2 TO  
11 EDA"), TO EXTEND THE PERFORMANCE DEADLINES FOR  
12 A PERIOD OF ONE YEAR, WITH ALL OTHER TERMS AND  
13 CONDITIONS REMAINING UNCHANGED; PROVIDING AN  
14 EFFECTIVE DATE.

16 **WHEREAS**, Eagle LNG Partners, LLC ("Company") and the City of  
17 Jacksonville ("City") previously entered into that certain Economic  
18 Development Agreement dated January 22, 2020, as authorized by  
19 Resolution 2019-844-A, to support the development of a liquified  
20 natural gas export facility located generally at 1632 Zoo Parkway,  
21 Jacksonville, Florida (as administratively amended one time  
22 previously, the "Economic Development Agreement"); and

23 **WHEREAS**, the Company has requested and OED has agreed to amend  
24 the Economic Development Agreement to extend the performance  
25 benchmarks therein for a period of one year, with all other terms  
26 and conditions of the Economic Development Agreement remaining  
27 unchanged; and

28 **WHEREAS**, it has been determined to be in the interest of the  
29 City to enter into the amended Economic Development Agreement and

1 approve of and adopt the matters set forth in this Ordinance; now  
2 therefore

3 **BE IT ORDAINED** by the Council of the City of Jacksonville:

4 **Section 1. Recitals.** The recitals set forth herein are  
5 true and correct.

6 **Section 2. Execution of Agreements.** The Mayor, or his  
7 authorized designee, and the Corporation Secretary are hereby  
8 authorized to execute and deliver an Amendment 2 to the Economic  
9 Development Agreement substantially in the form attached hereto as  
10 **Exhibit 1**, for the purpose of implementing the matters set forth in  
11 this Ordinance.

12 **Section 3. Effective Date.** This Ordinance shall become  
13 effective upon signature by the Mayor or upon becoming effective  
14 without the Mayor's signature.
