ORDINANCE 2021-243-E

AN ORDINANCE AUTHORIZING THE MAYOR, OR HIS AND THE CORPORATION SECRETARY TO DESIGNEE, EXECUTE AND DELIVER THAT CERTAIN STIPULATION OF PARTIES FOR THE CLOSURE OF PRESTON STREET RAILROAD-HIGHWAY GRADE CROSSING, FDOT CROSSING NUMBER 627867D, BETWEEN AND AMONG THE CITY OF JACKSONVILLE, THE JACKSONVILLE PORT AUTHORITY, AND THE STATE OF FLORIDA DEPARTMENT OF ("FDOT") FOR THE TRANSPORTATION PERMANENT CLOSURE OF A RAILROAD-HIGHWAY PUBLIC AT GRADE CROSSING ON PRESTON STREET; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Authorization. The Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City, that certain Stipulation of Parties for the Closure of Preston Street Railroad-Highway Grade Crossing, FDOT Crossing Number 627867D, between and among the City of Jacksonville, the Jacksonville Port Authority, and FDOT (the "Stipulation of Parties"), in substantially the form placed On File with the Office of Legislative Services. The Jacksonville Port Authority filed an application with FDOT to permanently close the Preston Street railroad-highway public at grade crossing. Pursuant to the Stipulation of Parties, the Jacksonville Port Authority will undertake all work necessary for closure of the railroad-highway

public at grade crossing, including but not limited to, removal of all evidence of the crossing, including restoration of the rightof-way and installation of permanent closure signs and object markers. All costs associated with the closure will be borne by the Jacksonville Port Authority. There is no current license agreement between the City and the Jacksonville Port Authority for this crossing and there will not be one once the crossing is
