WHEREAS, pursuant to Section 195.087, Florida Statutes, the Duval County Property Appraiser's Office ("Property Appraiser") submits its budget annually to the Department of Revenue on or before June 1; and

WHEREAS, pursuant to Section 106.201, Ordinance Code, the Mayor is required to submit the final annual Consolidated City of Jacksonville budget proposal, which includes the Property Appraiser's budget, to the City Council no later than July 15 annually; and

WHEREAS, during the weeks following July 15, the City Council Finance Committee reviews the budgets of the Property Appraiser along with the entire consolidated government as is required by the Charter Section 5.07; and

WHEREAS, therefore the review of the Property Appraiser's budget is simultaneously occurring with Department of Revenue and the City of Jacksonville; and

WHEREAS, although there is a provision for the Department of Revenue to include the City of Jacksonville's modifications to the Property Appraiser's budget, that information must be received from

the City Council, acting as the whole Council, prior to the Florida Department Appraiser's budget or alternatively subject to an appeal process;
