Please provide authorization for the Real Estate Division to request legislation necessary for City Council to execute a lease agreement in substantially the same form as attached. Vystar seeks to lease approximately 72 square feet just outside of the Hogan Street entrance of the St. James Building located at 117 West Duval Street in Council District 7. See RE# 073753-0000 and maps attached.

Vystar is currently at the end of its current lease which was for 1 year with a 1-year renewal option. This new lease is for 3 years with two 3-year renewal options, with a rental rate beginning at \$25.34 per square foot or \$1,824.48 annually. The new rate is consistent with a 3% increase from the last rental rate charged to the tenant. The new rate will continue to increase at 3% annually. This lease has been approved by the Facilities Planning Committee.


St. James Building Legal Description
