Section 4. Approval Requirements, Area and Authorization to Execute Documents. - Administrative Deviations (b) to reduce the minimum landscaping requirements pursuant to Section 656.109(d)(3), Ordinance Code.
- Sign Waivers pursuant to Section 656.133, Ordinance Code and Section 656.1310, Ordinance Code.

Section 6. Oversight Department. The Office of Economic Development shall oversee the Moncrief Area Business Improvement Program-Phase 1, as described herein.
