7 AN ORDINANCE APPROPRIATING FROM \$100,000 FROM  
8 THE SOCIAL JUSTICE AND COMMUNITY INVESTMENT  
9 SPECIAL COMMITTEE CONTINGENCY TO PARKS  
10 RECREATION AND COMMUNITY SERVICES DEPARTMENT -  
11 SOCIAL SERVICES DIVISION FOR EMERGENCY  
12 ASSISTANCE PROGRAM TO BE USED TO ASSIST THE  
13 HILLTOP RESIDENTS; PROVIDING FOR CITY  
14 OVERSIGHT BY THE PARKS, RECREATION AND  
15 COMMUNITY SERVICES DEPARTMENT; REQUESTING  
16 EMERGENCY PASSAGE UPON INTRODUCTION; PROVIDING  
17 AN EFFECTIVE DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1.** For the 2020-2021 fiscal year, within the  
21 City's budget, there are hereby appropriated the indicated sum(s)  
22 from the account(s) listed in subsection (a) to the account(s)  
23 listed in subsection (b):

31 The appropriation above provides \$100,000 in funding from

1 the Social Justice and Community Investment Special  
2 Committee Contingency account to Parks, Recreation and  
3 Community Services Department - Social Services Division  
4 for emergency assistance program to be used to assist the  
5 Hilltop residents for emergency assistance needs.

6 **Section 2. Purpose.** The purpose of the appropriation in  
7 Section 1 is to provide funding for to the Parks, Recreation and  
8 Community Services Department - Social Services Division to provide  
9 emergency assistance to the Hilltop residents, including but not  
10 limited to moving expenses, furniture replacement, security  
11 deposits, first and last rent, and utilities.

12 **Section 3. Oversight Department.** The Parks, Recreation  
13 and Community Services Department shall oversee the project  
14 described herein.

15 **Section 2. Requesting emergency passage upon introduction**  
16 **pursuant to Council Rule 4.901.** Emergency passage upon introduction  
17 of this Ordinance is requested due to the urgent needs of the  
18 Hilltop residents.

19 **Section 5. Effective Date.** This ordinance shall become  
20 effective upon signature by the Mayor or upon becoming effective  
21 without the Mayor's signature.
