7 AN ORDINANCE APPROPRIATING \$98,848 FROM THE
8 SOCIAL JUSTICE AND COMMUNITY INVESTMENT
9 SPECIAL COMMITTEE CONTINGENCY TO THE
10 DEPARTMENT OF PARKS, RECREATION AND COMMUNITY
11 SERVICES FOR ADDITIONAL PLAYGROUND EQUIPMENT
12 AT THE MARY LENA GIBBS COMMUNITY CENTER,
13 LOCATED AT 6974 WILSON BLVD., IN COUNCIL
14 DISTRICT 10; PROVIDING FOR A PROCUREMENT

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1.** For the 2020-2021 fiscal year, within the
19 City's budget, there are hereby appropriated the indicated sum(s)
20 from the account(s) listed in subsection (a) to the account(s)
21 listed in subsection (b):

28 (c) Explanation of Appropriation

29 The appropriation above provides \$98,848 in funding from
30 the Social Justice and Community Investment Special
31 Committee Contingency account to Department of Parks,

1 Recreation and Community Services for new playground
2 equipment at the Mary Lena Gibbs Community Center.

3 **Section 2. Purpose.** The purpose of the appropriation in
4 Section 1 is to provide funding to the Department of Parks,
5 Recreation and Community Services for additional playground
6 equipment at the Mary Lena Gibbs Community Center, located at 6974
7 Wilson Blvd., in Council District 10, as more particularly
8 described in **Exhibit 2** attached hereto.

9 **Section 3. Procurement Directive.** Prior to the
10 expenditure of any funds contemplated herein, the Department of
11 Parks, Recreation and Community Services shall obtain an
12 administrative award or purchasing tool from the Procurement
13 Division for the purchase amount not to exceed \$98,848 for the
14 playscape.

15 **Section 4. Effective Date.** This ordinance shall become
16 effective upon signature by the Mayor or upon becoming effective
17 without the Mayor's signature.
