4 **ORDINANCE 2021-403-E**

5 AN ORDINANCE WAIVING A PORTION OF SECTION
6 106.201 (A) (FINAL ANNUAL BUDGET; TIME OF
7 SUBMISSION), CHAPTER 106 (BUDGET AND
8 ACCOUNTING CODE), *ORDINANCE CODE*, TO ALLOW FOR
9 THE MAYOR TO DELIVER HIS BUDGET ORDINANCES AND
10 BUDGET MESSAGE ON TUESDAY, JULY 20, 2021 AT
11 9:00 A.M.; DIRECTING THE LEGISLATIVE SERVICES
12 DIVISION TO NOTICE THE CITY COUNCIL SPECIAL
13 MEETING FOR THE MAYOR'S BUDGET ADDRESS; AND
14 DIRECTING THE LEGISLATIVE SERVICES DIVISION TO
15 NOTICE THE FINANCE COMMITTEE MEETING TO BEGIN
16 IMMEDIATELY FOLLOWING THE MAYOR'S BUDGET
17 ADDRESS; REQUESTING EMERGENCY PASSAGE UPON
18 INTRODUCTION; PROVIDING AN EFFECTIVE DATE.

20 **WHEREAS**, Section 106.201(a), *Ordinance Code*, requires the
21 Mayor to submit the final annual budget proposal for the general
22 government to the City Council by filing a copy with Legislative
23 Services no later than July 15; and

24 **WHEREAS**, Section 106.201(a), further requires the final annual
25 budget proposal be accompanied by the Mayor's budget message; and

26 **WHEREAS**, the Council desires to have the Mayor give his budget
27 message on Tuesday, July 20, 2021 at 9:00 a.m.; now therefore

28 **BE IT ORDAINED** by the Council of the City of Jacksonville:

29 **Section 1. Waiver of a portion of Section 106.201(a),**
30 ***Ordinance Code***. A portion of Section 106.201(a) (Final Annual
31 Budget; Time of Submission), Chapter 106 (Budget and Accounting

1 Code) *Ordinance Code*, is hereby waived to allow for the Mayor to
2 deliver his budget ordinances and budget message on Tuesday, July
3 20, 2021 at 9:00 a.m.

4 **Section 2. Directing Legislative Services to Notice the**
5 **City Council Special Meeting.** The Legislative Services Division is
6 hereby directed to publically notice the City Council special
7 meeting for the Mayor's budget address at 9:00 a.m. on Tuesday,
8 July 20, 2021.

9 **Section 3. Directing Legislative Services to Notice the**
10 **Finance Committee meeting.** The Legislative Services Division is
11 hereby directed to notice the Finance Committee meeting to occur
12 immediately following the Mayor's budget addresss.

13 **Section 4. Requesting Emergency Passage Upon Introduction**
14 **Pursuant to Council Rule 4.901 Emergency.** Emergency passage upon
15 introduction of this legislation is requested. The nature of the
16 emergency is that 106.201(a), *Ordinance Code*, requires the Mayor to
17 submit the final annual budget proposal for the general government
18 to the City Council by filing a copy with Legislative Services no
19 later than July 15 and further requires the final annual budget
20 proposal be accompanied by the Mayor's budget message.

21 **Section 5. Effective Date.** This Ordinance shall become
22 effective upon signature by the Mayor or upon becoming effective
23 without the Mayor's signature.
