5 AN ORDINANCE REGARDING PUBLIC SERVICE GRANTS;  
6 APPROPRIATING \$3,147,080 FROM A DESIGNATED  
7 SPECIAL COUNCIL CONTINGENCY ACCOUNT FOR PUBLIC  
8 SERVICE GRANTS; PROVIDING FOR CITY OVERSIGHT BY  
9 THE OFFICE OF GRANTS AND CONTRACT COMPLIANCE OF  
10 THE DEPARTMENT OF FINANCE AND ADMINISTRATION;  
11 WAIVING THE CONFLICTING PROVISION OF §118.802  
12 (ANNUAL LUMP SUM APPROPRIATION FOR PUBLIC SERVICE  
13 GRANTS), *ORDINANCE CODE*, DUE TO THE NEED FOR  
14 SEPARATE LEGISLATION FROM THE ANNUAL BUDGET  
15 ORDINANCE TO APPROVE THE LUMP SUM APPROPRIATION  
16 FOR PUBLIC SERVICE GRANTS; PROVIDING AN EFFECTIVE  
17 DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2021-2022 fiscal year,  
21 within the City's budget, there are hereby appropriated the indicated  
22 sum(s) from the account(s) listed in subsection (a) to the account(s)  
23 listed in subsection (b):

30 **Explanation of Appropriation** - The funding above is being  
31 appropriated from the designated Council Contingency account for

1 Public Service Grants.

2 **Section 2. Purpose.** The Public Service Grant  
3 appropriation made in **Exhibit 2** shall be used only for the purpose  
4 of the listed Public Service Grant Appropriations and may not be  
5 transferred or reallocated for any other utilization within the  
6 respective department. Public Service Grants are subject to the  
7 provisions of Chapter 118, Ordinance Code. The appropriations made  
8 herein shall be awarded as grants-in-aid to the miscellaneous  
9 agencies, and shall not require additional legislation for  
10 distribution of funds. Pursuant to Section 118.808, *Ordinance Code*,  
11 the Public Service Grant Council shall forward a complete list of the  
12 Public Service Grants recipients and funding allocation to the Council  
13 Auditor's office, the Office of the Mayor, the City Council and the  
14 Director of the Finance and Administration Department.

15 **Section 3. Oversight Department.** The Office of Grants and  
16 Contract Compliance of the Finance and Administration Department  
17 shall oversee the project described herein.

18 **Section 4. Waiving conflicting provision of §118.802**  
19 **(Annual Lump Sum Appropriation for Public Service Grants), Ordinance**  
20 **Code.** The conflicting provision of §118.802 (Annual Lump Sum  
21 Appropriation for Public Service Grants), *Ordinance Code*, referring  
22 to "the annual budget ordinance" is hereby waived. Waiver of Section  
23 118.802, *Ordinance Code*, is necessary because the Public Service  
24 Grant lump sum appropriation for the 2021-2022 annual budget will be  
25 considered by Council not in the annual budget Ordinance 2021-504,  
26 but rather in a separate Ordinance 2021-509.

27 **Section 5. Effective Date.** This ordinance shall become  
28 effective upon signature by the Mayor or upon becoming effective  
29 without the Mayor's signature.
