Grant 3 appropriation made in **Exhibit 2** shall be used only for the purpose of the listed Public Service Grant Appropriations and may not be 4 transferred or reallocated for any other utilization within the 5 respective department. Public Service Grants are subject to the 6 7 provisions of Chapter 118, Ordinance Code. The appropriations made 8 herein shall be awarded as grants-in-aid to the miscellaneous 9 agencies, and shall not require additional legislation for 10 distribution of funds. Pursuant to Section 118.808, Ordinance Code, the Public Service Grant Council shall forward a complete list of the 11 Public Service Grants recipients and funding allocation to the Council 12 Auditor's office, the Office of the Mayor, the City Council and the 13 14 Director of the Finance and Administration Department.

Section 3. Oversight Department. The Office of Grants and
Contract Compliance of the Finance and Administration Department
shall oversee the project described herein.

Section 4. Waiving conflicting provision of §118.802 18 (Annual Lump Sum Appropriation for Public Service Grants), Ordinance 19 20 Code. The conflicting provision of \$118.802 (Annual Lump Sum 21 Appropriation for Public Service Grants), Ordinance Code, referring 22 to "the annual budget ordinance" is hereby waived. Waiver of Section 118.802, Ordinance Code, is necessary because the Public Service 23 Grant lump sum appropriation for the 2021-2022 annual budget will be 24 25 considered by Council not in the annual budget Ordinance 2021-504, 26 but rather in a separate Ordinance 2021-509.

27 Section 5. Effective Date. This ordinance shall become 28 effective upon signature by the Mayor or upon becoming effective 29 without the Mayor's signature.
