4 **RESOLUTION 2021-362-A**

5 A RESOLUTION DESIGNATING THE JACKSONVILLE  
6 SYSTEM OF CARE FOR CHILDREN'S MENTAL HEALTH,  
7 ACTING THROUGH THE KIDS HOPE ALLIANCE, A CITY  
8 DEPARTMENT, AS THE COUNTY PLANNING COUNCIL  
9 PURSUANT TO SECTION 394.657, FLORIDA STATUTES,  
10 AND ASSIGNING THE PREPARATION AND SUBMISSION  
11 OF GRANT APPLICATIONS TO THE CRIMINAL JUSTICE,  
12 MENTAL HEALTH, AND SUBSTANCE ABUSE  
13 REINVESTMENT GRANT PROGRAM TO THIS ENTITY,  
14 THROUGH THE KIDS HOPE ALLIANCE; ESTABLISHING  
15 MEMBERSHIP OF COMMITTEE PURSUANT TO SECTION  
16 394.657, FLORIDA STATUTES; PROVIDING AN  
17 EFFECTIVE DATE.

19 **WHEREAS**, Section 394.657, *Florida Statutes*, provides that a  
20 county must designate a criminal or juvenile justice mental health  
21 and substance abuse council or committee as the county planning  
22 council for purposes of making a formal recommendation to the  
23 governing body regarding how the Criminal Justice, Mental Health,  
24 and Substance Abuse Reinvestment Grant Program (created pursuant to  
25 Section 394.656, *Florida Statutes*) may be best implemented within  
26 the community; and

27 **WHEREAS**, the governing body may assign to such county planning  
28 council the ability to prepare applications on behalf of the county  
29 for submission to the Criminal Justice, Mental Health, and  
30 Substance Abuse Statewide Grant Review Committee for review; and

31 **WHEREAS**, the City of Jacksonville, as a consolidated city-

1 county form of government, wishes to designate the Jacksonville  
2 System of Care for Children's Mental Health, acting through the  
3 Kids Hope Alliance, a City of Jacksonville Department, as the  
4 planning council for purposes of Section 394.657, *Florida Statutes*;  
5 now therefore

6 **BE IT RESOLVED** by the Council of the City of Jacksonville:

7 **Section 1.** The City Council of the City of Jacksonville  
8 hereby designates the Jacksonville System of Care for Children's  
9 Mental Health, acting through the Kids Hope Alliance, a City  
10 Department, as the county planning council authorized by Section  
11 394.657, *Florida Statutes*.

12 **Section 2. Membership Requirements.** The membership of the  
13 designated planning council shall include those particular members  
14 or their designees identified in Section 394.657, *Florida Statutes*.  
15 Due to the consolidated form of government in Duval County, for  
16 certain required designations relating to county offices, the  
17 equivalent City of Jacksonville counterpart organization will be  
18 selected as applicable and notated in applications under Sections  
19 394.656 and 394.657, *Florida Statutes*, and matters related thereto.

20 **Section 3. Effective Date.** That this Resolution shall  
21 become effective upon signature by the Mayor or upon becoming  
22 effective without the Mayor's signature.
