AN ORDINANCE APPROVING, AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND CORPORATION SECRETARY TO EXECUTE AND DELIVER THAT CERTAIN LEASE AGREEMENT BETWEEN MIDTOWN CENTRE OFFICE, LLC ("LANDLORD") AND THE CITY OF JACKSONVILLE ("TENANT") TO LEASE APPROXIMATELY 3,629 SQUARE FEET OF SPACE IN THE 3100 BUILDING (SUITE 100) OF THE MIDTOWN CENTRE OFFICE PARK, LOCATED AT EXECUTIVE CENTER DRIVE, JACKSONVILLE, FLORIDA 32207 (R.E. #129627-0040), IN COUNCIL DISTRICT 5, FOR USE BY THE JACKSONVILLE SHERIFF'S OFFICE FOR ITS INTEGRITY UNIT, FOR AN INITIAL TERM OF FIVE (5) YEARS WITH AN OPTION TO RENEW FOR ONE (1) ADDITIONAL FIVE (5) YEAR TERM, AT AN INITIAL RENTAL RATE OF \$4,989.88 PER MONTH, WITH THREE PERCENT (3%) ANNUAL INCREASES THEREAFTER; PROVIDING OVERSIGHT OF LEASE ACQUISITION AND EXECUTION BY THE REAL ESTATE DIVISION OF THE DEPARTMENT PUBLIC WORKS, AND THEREAFTER JACKSONVILLE SHERIFF'S OFFICE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Lease Agreement Approved and Execution

Authorized. There is hereby approved, and the Mayor, or his

designee, and Corporation Secretary are hereby authorized to

execute and deliver that certain Lease Agreement between the City of Jacksonville and Midtown Centre Office, LLC (the "Lease"), in substantially the same form as has been placed **On File** with the Office of Legislative Services. The Lease provides for use of approximately 3,629 square feet of space in the 3100 Building (Suite 100) of the Midtown Centre Office Park located at 1800 Executive Center Drive, Jacksonville, Florida 32207 (R.E. #129627-0040) in Council District 5, by the Jacksonville Sheriff's Office for its Integrity Unit, subject to the terms and conditions outlined therein. The Lease has an initial term of five (5) years with an option to renew for one (1) additional five (5) year term. The initial rental rate is \$4,989.88 per month, with an escalation rate of three percent (3%) per year thereafter.

Section 2. Oversight Department. The Real Estate Division of the Department of Public Works shall provide initial oversight of Lease acquisition and execution and the Jacksonville Sheriff's Office shall provide oversight of the Lease thereafter.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
