7 A RESOLUTION CONFIRMING THE JACKSONVILLE
8 ETHICS COMMISSION'S APPOINTMENT OF KIRBY G.
9 OBERDORFER, A REGISTERED DUVAL COUNTY VOTER,
10 AS THE DIRECTOR OF THE OFFICE OF ETHICS,
11 COMPLIANCE AND OVERSIGHT (ECO) FOR THE CITY OF
12 JACKSONVILLE, PURSUANT TO SECTION 602.612,
13 *ORDINANCE CODE*, FOR A THREE YEAR TERM ENDING
14 SEPTEMBER 30, 2024; PROVIDING FOR A
15 PROSPECTIVE EFFECTIVE DATE; PROVIDING AN

18 **WHEREAS**, on June 1, 2021, the Jacksonville Ethics Commission
19 voted to appoint Kirby G. Oberdorfer to serve as the next City of
20 Jacksonville's Director of the Office of Ethics, Compliance and
21 Oversight, a copy of the Ethics Commission's meeting minutes is

23 **BE IT RESOLVED** by the Council of the City of Jacksonville:

24 **Section 1. Council Confirmation.** The Council hereby
25 confirms the Jacksonville Ethics Commission's appointment of Kirby
26 G. Oberdorfer, a registered Duval County voter, as the City of
27 Jacksonville's next Director of the Office of Ethics, Compliance
28 and Oversight, pursuant to Section 602.612, *Ordinance Code*, for a
29 three year term ending on September 30, 2024. A copy of Ms.
30 Oberdorfer's Resume is attached hereto as **Exhibit 2**.

31 **Section 2. Prospective Effective Date.** This appointment

1 shall become effective October 1, 2021, due to the retirement of
2 the current Director of the Office of Ethics, Compliance and
3 Oversight effective September 30, 2021.

4 **Section 3. Effective Date.** This Resolution shall become
5 effective upon signature by the Mayor or upon becoming effective
6 without the Mayor's signature.
