ORDINANCE 2021-539

AN ORDINANCE APPROVING SIGN WAIVER APPLICATION SW-21-06 FOR A SIGN LOCATED IN COUNCIL DISTRICT 4 AT 6349 BEACH BOULEVARD, BETWEEN RYAR ROAD AND HICKMAN ROAD AS DESCRIBED HEREIN, OWNED BY ZEUS & ZEUS TRUST 0517, REQUESTING TO REDUCE THE MINIMUM SETBACK FROM 10 FEET TO 0 FEET, IN ZONING DISTRICT COMMERCIAL COMMUNITY/GENERAL-2 (CCG-2), AS DEFINED AND CLASSIFIED UNDER THE ZONING CODE; PROVIDING A DISCLAIMER THAT THE WAIVER GRANTED HEREIN SHALL <u>NOT</u> BE CONSTRUED AS AN EXEMPTION FROM ANY OTHER APPLICABLE LAWS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, an application for a waiver of requirements for signs, On File with the City Council Legislative Services Division, was filed by Ken Bringle, on behalf of the owner of property located in Council District 4 at 6349 Beach Boulevard, between Ryar Road and Hickman Road (the "Subject Property"), requesting to reduce the minimum setback from 10 feet to 0 feet, in Zoning District Commercial Community/General-2 (CCG-2); and

WHEREAS, the Planning and Development Department has considered the application and all the attachments thereto and has rendered an advisory recommendation (the "Staff Report"); and

WHEREAS, the Land Use and Zoning Committee, after due notice, held a public hearing, and having duly considered both the testimonial and documentary evidence presented at the public hearing, has made its recommendation to the Council; and WHEREAS, taking into consideration the above recommendations and all other evidence entered into the record and testimony taken at the public hearings, the Council has considered the criteria for sign waivers pursuant to Sec. 656.133(c), Ordinance Code, and finds that the request is in harmony with the spirit and intent of the Zoning Code and should be approved; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. The Council has considered the sign waiver 8 9 criteria pursuant to Sec. 656.133(c), Ordinance Code, the 10 recommendation of the Land Use and Zoning Committee, and has reviewed the Staff Report of the Planning and Development Department concerning 11 sign waiver Application SW-21-06 and finds that the waiver is in 12 harmony with the spirit and intent of the Zoning Code, considering 13 the following criteria, as applicable: 14

(1) The effect of the sign waiver is compatible with the existing contiguous signage or zoning and consistent with the general character of the area considering population, density, scale, and orientation of the structures in the area;

(2) The result will not detract from the specific intent of the Zoning Code by promoting the continued existence of nonconforming signs that exist in the vicinity;

(3) The effect of the proposed waiver will not diminish property values in, or negatively alter the aesthetic character of the area surrounding the site, and will not substantially interfere with or injure the rights of others whose property would be affected by the same;

(4) The waiver will not have a detrimental effect on vehicular
or pedestrian traffic or parking conditions, or result in the creation
of objectionable or excessive light, glare, shadows, or other effects,
taking into account existing uses and zoning in the vicinity;

(5) The proposed waiver will not be detrimental to the public

1 health, safety or welfare, and will not result in additional public 2 expense, creation of nuisances, or cause conflict with any other 3 applicable law;

4 (6) The Subject Property exhibits specific physical limitations
5 or characteristics which are unique to the site and which would make
6 imposition of the strict letter of the regulation unduly burdensome;

7 (7) The request is not based exclusively upon a desire to reduce 8 the costs associated with compliance and is the minimum necessary to 9 obtain a reasonable communication of one's message;

10 (8) If the request is the result of a violation that has existed 11 for a considerable length of time without receiving a citation, 12 whether the violation that exists is a result of construction that 13 occurred prior to the applicant's acquisition of the property, and 14 not as a direct result of the actions of the current owner;

(9) The request accomplishes a compelling public interest, such as, for example, furthering the preservation of natural resources by saving a tree or trees; and

18 (10) Strict compliance with the regulation will create a19 substantial financial burden when considering cost of compliance.

20 Therefore, sign waiver Application SW-21-06 is hereby **approved**.

21 Section 2. Owner, Property and Sign Description. The 22 Subject Property is owned by Zeus & Zeus Trust 0517, and is legally 23 described in Exhibit 1, attached hereto, dated September 17, 2020, and graphically depicted in Exhibit 2, attached hereto. A graphic 24 25 depiction of the sign is **attached hereto** as **Exhibit 3**. The applicant 26 is Ken Bringle, 263 Edgewood Avenue South, Jacksonville, Florida 32254; (904) 425-3363. 27

28 Section 3. Notice. Legislative Services is hereby directed 29 to mail a copy of this legislation, as enacted, to the applicant and 30 any other parties to this matter who testified before the Land Use 31 and Zoning Committee or otherwise filed a qualifying written statement

as defined in Section 656.140(c), Ordinance Code.

2 Section 4. **Disclaimer.** The sign waiver granted herein 3 shall **not** be construed as an exemption from any other applicable local, state, or federal laws, regulations, requirements, permits or 4 5 approvals. All other applicable local, state or federal permits or approvals shall be obtained before commencement of the development 6 7 or use and issuance of this sign waiver is based upon acknowledgement, representation and confirmation made by the applicant(s), owner(s), 8 9 developer(s) and/or any authorized agent(s) or designee(s) that the 10 subject business, development and/or use will be operated in strict compliance with all laws. Issuance of this sign waiver does not 11 approve, promote or condone any practice or act that is prohibited 12 or restricted by any federal, state or local laws. 13

Section 5. Effective Date. The enactment of this Ordinance shall be deemed to constitute a quasi-judicial action of the City Council and shall become effective upon signature by the Council President and Council Secretary. Failure to exercise the waiver, if herein granted, by commencement of the use or action herein approved within one year of the effective date of this Ordinance shall render this waiver invalid and all rights arising therefrom shall terminate.
