4 **ORDINANCE 2021-595**

5 AN ORDINANCE APPROPRIATING A \$610,000.00 GRANT
6 FROM THE FLORIDA DEPARTMENT OF TRANSPORTATION
7 ("FDOT") TO FUND CONSTRUCTION AND CONSTRUCTION
8 OVERSIGHT FOR INSTALLATION OF AN INTELLIGENT
9 TRANSPORTATION SYSTEM ON BAY STREET FROM I-95 TO
10 FESTIVAL PARK DRIVE (THE "PROJECT"), AS
11 INITIATED BY B.T. 21-110; PURPOSE OF THE
12 APPROPRIATION; APPROVING, AND AUTHORIZING THE
13 MAYOR, OR HIS DESIGNEE, AND THE CORPORATION
14 SECRETARY TO EXECUTE AND DELIVER, FOR AND ON
15 BEHALF OF THE CITY, THE LOCAL AGENCY PROGRAM
16 AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND
17 FDOT; AMENDING THE 2021-2025 FIVE-YEAR CAPITAL
18 IMPROVEMENT PLAN APPROVED BY ORDINANCE 2020-505-
19 E TO REFLECT FDOT GRANT FUNDING FOR THE PROJECT;
20 PROVIDING FOR OVERSIGHT BY THE ENGINEERING AND
21 CONSTRUCTION MANAGEMENT DIVISION OF THE
22 DEPARTMENT OF PUBLIC WORKS; PROVIDING AN
23 EFFECTIVE DATE.

25 **BE IT ORDAINED** by the Council of the City of Jacksonville:

26 **Section 1. Appropriation.** For the 2020-2021 fiscal year,
27 within the City's budget, there are hereby appropriated the indicated
28 sum(s) from the account(s) listed in subsection (a) to the account(s)
29 listed in subsection (b):

5 (c) Explanation of Appropriation:

6 The funding above represents a grant from the Florida
7 Department of Transportation ("FDOT") for the City's
8 construction and construction oversight of the Project.

9 **Section 2. Purpose.** The purpose of the appropriation in
10 Section 1 is to fund the costs of construction and construction
11 oversight for installation of an Intelligent Transportation System
12 on Bay Street from I-95 to Festival Park Drive. The purpose of the
13 Project is to provide greater stormwater resiliency, traffic cameras
14 for transportation operations and public safety, and fiber-optic
15 communications for future expansion opportunities.

16 **Section 3. Approval and Authorization.** There is hereby
17 approved, and the Mayor, or his designee, and the Corporation
18 Secretary are hereby authorized to execute and deliver, for and on
19 behalf of the City, the Local Agency Program Agreement between the
20 City and FDOT, in substantially the same form as has been placed **On**
21 **File** with the Office of Legislative Services.

22 **Section 4. Capital Improvement Plan Amendment.** Ordinance
23 2020-505-E, adopting the 2021-2025 Five-Year Capital Improvement Plan
24 (the "CIP") for the City and certain of its independent agencies, is
25 hereby amended to provide funding for the Project, as more fully
26 described in the Project Information Sheet, attached hereto as **Exhibit**
27 **2** and incorporated herein by this reference. The City Council finds
28 that the deferral of this amendment of the CIP until the next annual
29 budget and CIP review will be detrimental to the best interests of
30 the community because such deferral will result in unnecessary delay
31 of the Project and loss of grant funding for the Project. Pursuant

1 to Section 122.605(c), *Ordinance Code*, enactment of this Ordinance
2 requires the affirmative vote of two-thirds of the City Council
3 members present at the meeting because of the CIP amendment set forth
4 in this section. This Ordinance shall constitute an amendment to
5 Ordinance 2020-505-E. In all other respects, the Five-Year Capital
6 Improvement Plan approved by Ordinance 2020-505-E shall remain
7 unchanged and continue in full force and effect.

8 **Section 5. Departmental Oversight.** The Engineering and
9 Construction Management Division of the Department of Public Works
10 shall oversee the Project.

11 **Section 6. Effective Date.** This Ordinance shall become
12 effective upon signature by the Mayor or upon becoming effective
13 without the Mayor's signature.
