AN INITIAL ASSESSMENT ORDINANCE PURSUANT TO CHAPTER 170, FLORIDA STATUTES, AND CHAPTER SPECIAL 715, ORDINANCE CODE, AUTHORIZING ASSESSMENTS TO PRIVATE HOSPITAL PROPERTY AS DESCRIBED HEREIN; PROVIDING THE AUTHORITY FOR THE SPECIAL ASSESSMENT AND MAKING FINDINGS; DESCRIBING THE NATURE OF THE PROGRAM OR SERVICES TO BE PROVIDED; PROVIDING THE METHOD OF APPORTIONMENT, DETERMINING THE SERVICE COST TO BE ASSESSED, IDENTIFYING THE PROPERTIES TO BE ASSESSED AND EXEMPTIONS; IDENTIFYING THE SERVICE AREA; ESTABLISHING THE ASSESSMENT RATE AND TERM; SETTING A PUBLIC HEARING FOR THE FINAL ASSESSMENT ORDINANCE; DIRECTING THE NOTICE OF THE INITIAL ASSESSMENT ROLL TO BE PUBLISHED AND MAILED AS REQUIRED BY SECTION 715.204 AND 715.205 ORDINANCE CODE AND 170.07, FLORIDA STATUTES, RETAINING ALL RIGHTS GRANTED BY CHAPTER 170, FLORIDA STATUTES; PROVIDING FOR OVERSIGHT BY THE FINANCE AND ADMINISTRATION DEPARTMENT; REQUESTING ONE CYCLE EMERGENCY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, hospitals located within the Consolidated City of

Jacksonville (the "Hospitals") annually provide millions of dollars of uncompensated care to persons who qualify for Medicaid because Medicaid, on average, covers only 60% of the costs of the health care services actually provided by the Hospitals to Medicaid eligible persons, leaving the Hospitals with significant uncompensated costs ("Medicaid shortfall"); and

WHEREAS, the State of Florida (the "State") has received federal authority to establish the Statewide Medicaid Managed Care Hospital Directed Payment Program to offset Medicaid shortfalls for hospitals statewide and to improve the quality of care provided to Florida's Medicaid population; and

WHEREAS, the impacted Hospitals have asked the City of Jacksonville to impose a special assessment upon certain real property owned by the Hospitals to help finance the non-federal share of the State's Medicaid program to improve the quality of care provided to Florida's Medicaid population; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Authority and Findings. This Initial Assessment Ordinance is adopted pursuant to the authority granted in Chapter 170, Florida Statutes, Chapter 715, Ordinance Code, and home rule powers conferred upon municipalities and chartered counties by Article VIII of the Florida Constitution and Chapters 125 and 166, Florida Statutes. Pursuant to Sections 170.201(1) and 170.01(2), Florida Statutes, and Section 715.201, Ordinance Code, the City Council finds that providing municipal services at the rate of assessment established herein to the real property identified in the service area described herein provides a special benefit to such property, which is different in type or degree from benefits provided to the community as a whole. This Ordinance shall serve as the resolution required to declare the terms of the special assessments pursuant to Section 170.03, Florida Statutes,

the publication requirements under Section 170.07, Florida Statutes, and shall serve as the Initial Assessment Ordinance required by Section 715.202, Ordinance Code.

be Funded by Special Assessment. Pursuant to Sections 170.201(1) and 170.03, Florida Statutes, and Section 715.202(a), Ordinance Code, the nature of the proposed program to be funded by this special assessment is to finance the non-federal share of the State's Medicaid program thus stabilizing and improving quality of care provided to Florida's Medicaid population ("Medical Services") by assessing only the properties benefitted by this program.

Method of Apportionment; Service Cost to be Assessed; Properties to be Assessed and Exemptions. Pursuant to 170.02 and 170.03, Florida Statutes, and 715.202(b) and 715.202(c), Ordinance Code, the method for assessing properties shall be by an annual rate applied to each property. The current estimated rate is 0.24% of gross patient revenue, although the Hospitals realize that this figure is an estimate and is subject to change. The cost, or total estimated cost, is currently estimated to be \$115,494,788.00. The service cost associated with the program is \$150,000.00. The properties to be assessed are described in Revised Exhibit 1, labeled as "Revised Exhibit 1, Rev Assessment, August 16, 2021 - NCSPHS", attached hereto. There are no exempt properties included in the service area.

Section 4. Service Area. Pursuant to Section 170.03, Florida Statutes, and Section 715.202(e), Ordinance Code, the service area where Hospitals shall be assessed is limited to hospitals licensed by the Florida Agency for Health Care Administration (the "AHCA") as "hospitals" in accordance with the section 395.002(12), Florida Statutes, which are more specifically

Section 8. Publication of Notice and Mailing of Notices.

Section 5. Establishment of Estimated Assessment Rate and Term. Pursuant to Section 170.03, Florida Statutes, and Section 715.202(f), Ordinance Code, the estimated special assessment rate shall be equal to 0.23% of the gross patient revenue for each Hospital property. This figure will cover the shortfall based on utilization from October 2020-September 2021. All Hospitals recognize that this figure may change depending on the final figures from AHCA. The term for this special assessment shall be annual, to be assessed and collected each year, until withdrawn.

Section 6. Public Hearing for Final Assessment Ordinance. Pursuant to Section 170.07, Florida Statutes, and 715.202(h) and 715.302, Ordinance Code, the City Council hereby sets the date, time and place of a public hearing to consider the adoption of the Final Assessment Ordinance as September 28, 2021, p.m., in Council Chambers, 117 West Duval Street, Jacksonville, Florida 32202. The Office of General Counsel is directed to prepare the Final Assessment Ordinance for introduction at City Council on September 14, 2021, with final action and public hearing scheduled for September 28, 2021.

Initial Assessment Roll. Pursuant to Section Section 7. 170.06, Florida Statutes and Section 715.202(i)(1) and Section 715.203, Ordinance Code, the estimated Initial Assessment Roll is attached hereto as Revised Exhibit 2, labeled as "Revised Exhibit 2, Rev Assessment Roll, August 16, 2021 - NCSPHS". The Initial Assessment Roll is an estimate based on the currently available data from AHCA, which may require adjustment prior to the Final Assessment Roll once AHCA finalizes the figures.

The City Council hereby directs the Mayor, on behalf of the City of Jacksonville, to:

- (a) Publish notice as required by Section 170.05, Florida Statutes, and Section 715.204, Ordinance Code.
- (b) Mail notices as required by Section 170.07, Florida Statutes, and Section 715.205, Ordinance Code.

Section 9. Retaining All Rights Granted by Chapter 170, Florida Statutes. The City of Jacksonville hereby retains all rights granted to municipalities by Chapter 170, Florida Statutes, for the special assessments authorized herein, including priority of lien, interest and foreclosure; provided, however, that any legal proceeding to enforce payment of such special assessments shall require City Council approval.

Section 10. Oversight. The Department of Finance and Administration shall provide oversight.

Section 11. Requesting one cycle emergency passage pursuant to Council Rule 4.901 Emergency. One cycle emergency passage of this Ordinance is requested. The nature of the emergency is that this Ordinance must be adopted in compliance with the necessary legal requirements for special assessments prior to the October AHCA deadline for remittance of the funds to the State.

Section 12. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
