6 Section 2. Purpose. The purpose of the appropriation in 7 Section 1 is to provide funds for the demolition of mobile office 8 trailers and the old stage, including demolition of the stage 9 building, stage flooring, stage concrete foundation, and associated 10 concrete pavement. These funds will also be used to restore concrete 11 sidewalk connections.
