31	Section 2. Purpose. The purpose of the appropriation in

Section 1 is to establish the fiscal year 2021-2022 operating budget 1 2 for the Inmate Welfare Trust Fund in accordance with Section 111.300, 3 Ordinance Code, and Section 951.23(9), Florida Statutes. The appropriation includes: \$112,786.46 in various salary accounts for 4 employees whose duties directly relate to the Trust Fund; \$347.00 in 5 Workers' Compensation benefits for employees whose duties directly 6 7 relate to the Trust Fund; \$3,201.00 in general liability insurance; \$464,519.07 for admission packs, indigent packs, law library 8 9 supplies, recreational equipment, replacement servers for existing 10 security cameras, and other related items; and, \$706,273.45 in "Specialized Equipment" for various capital equipment items at the 11 Montgomery Correctional Facility, the Community Transition Facility, 12 and the Pre-Trial Detention Facility. There are no requirements for 13 a local match or additional staffing obligations. 14

Section 3. Authorization of Position. There is hereby authorized the position more fully described in R.C. 22-004, attached hereto as Exhibit 2 and incorporated herein by this reference.
