## ORDINANCE 2021-670

AN ORDINANCE APPROPRIATING \$30,839,253.40 IN EMERGENCY RENTAL ASSISTANCE GRANT FUNDS FROM THE U.S. DEPARTMENT OF TREASURY IN ACCORDANCE WITH THE AMERICAN RESCUE PLAN ACT OF 2021 ESTABLISHED IN SECTION 3201(A) PUB. L. NO. 117-2 (MARCH 11, 2021) (THE "ARP ACT") TO PROVIDE ADDITIONAL EMERGENCY RENT AND UTILITY ASSISTANCE ТО ELIGIBLE HOUSEHOLDS IN DUVAL COUNTY, FLORIDA (THE "ERA 2 PROGRAM"), AS INITIATED BY B.T. 21-130; PROVIDING A CARRYOVER OF FUNDS FROM YEAR TO YEAR UNTIL SUCH FUNDS ARE EXPENDED OR LAPSE; INVOKING THE EXCEPTION OF SECTION 126.107(G) (EXEMPTIONS), PART 1 (GENERAL REGULATIONS), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH CIVITAS, LLC; APPROVING AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER A CONTRACT WITH CIVITAS, LLC FOR THE PROVISION OF CONTRACTUAL SERVICES FOR ERA 2 PROGRAM AS DESCRIBED THE IN THIS ORDINANCE; WAIVING SECTION 110.112 (ADVANCE OF CITY FUNDS; PROHIBITION AGAINST), PART 1 (THE CITY TREASURY), CHAPTER 110 (CITY TREASURY), ORDINANCE CODE, TO ALLOW FOR ADVANCE PAYMENT TO CIVITAS, LLC AS DESCRIBED IN THIS ORDINANCE; PROVIDING FOR OVERSIGHT BY THE HOUSING AND COMMUNITY DEVELOPMENT DIVISION, NEIGHBORHOODS

1 DEPARTMENT; PROVIDING FOR COMPLIANCE WITH APPLICABLE ARP ACT GRANT FUNDING REQUIREMENTS; 2 3 REOUESTING EMERGENCY PASSAGE UPON INTRODUCTION; PROVIDING AN EFFECTIVE DATE. 4 5 BE IT ORDAINED by the Council of the City of Jacksonville: 6 7 Section 1. Appropriation. For the 2020-2021 fiscal year, 8 within the City's budget, there are hereby appropriated the indicated 9 sum(s) from the account(s) listed in subsection (a) to the account(s) 10 listed in subsection (b): (B.T. 21-130 attached hereto as **Exhibit 1** and incorporated herein by 11 12 this reference) 13 (a) Appropriated from: See B.T. 21-130 \$30,839,253.40 14 15 (b) Appropriated to: See B.T. 21-130 \$30,839,253.40 16 (c) Explanation of Appropriation: 17 18 The funding above is an appropriation of American Rescue Plan Act (the "ARP Act") Emergency Rental Assistance grant 19 20 funds from the U.S. Department of Treasury in the amount 21 of \$30,839,253.40 (the "ERA 2 Program Funds"). The ERA 2 22 Program Funds will be used to provide emergency rent and 23 utility assistance to eligible households to mitigate the 24 impacts of COVID-19. A total disbursement of ERA 2 Program 25 Funds will be made to Civitas, LLC in the amount of 26 \$30,068,272.07, of which \$27,755,328.06 will be for direct 27 assistance to eligible households in Duval County and \$2,312,944.01 will be used to cover Civitas, LLC's 28 29 administrative costs (project management fee). An initial lump sum advance payment of \$10,177,918.77 will be made to 30 Civitas, LLC, of which \$10,000,000.00 will be for direct 31

assistance to eligible households and \$177,918.77 will be 1 for the first monthly installment of Civitas, LLC's 2 3 administrative costs (project management fee) for the period commencing September 1, 2021 through September 30, 4 5 2021. The remaining \$17,755,328.06 in direct assistance funds will be disbursed to Civitas, LLC, as needed based 6 7 on the applications received and confirmed eligible for The remaining \$2,135,025.24 set aside 8 funding. for 9 Civitas, LLC's administrative costs will be paid monthly, on a reimbursement basis, in accordance with the agreement 10 between the City and Civitas, LLC authorized herein. 11 The remaining ERA 2 Program Funds appropriated herein will 12 cover the City's costs for oversight of the ERA 2 Program 13 as reflected in Exhibit 1. The period of performance for 14 15 the ARP Act Emergency Rental Assistance grant commences May 21, 2021 through September 30, 2025. 16

17 Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide emergency rent and utility assistance to 18 eligible households in Duval County to mitigate the impacts of COVID-19 20 19. The City will partner with Civitas, LLC who will provide services 21 as more specifically described in this Ordinance for efficient administration of the ERA 2 Program and distribution of the ERA 2 22 Program Funds. Eligible households are households of 1 or more 23 24 individuals who are obligated to pay rent on a residential unit 25 located in Duval County, Florida and with respect to which the City 26 of Jacksonville (or it's duly authorized ERA 2 Program subcontractor) 27 determines that: (1) 1 or more individuals within the household has 28 qualified for unemployment benefits or has experienced a reduction 29 in household income, incurred significant costs, or experienced other financial hardship during or due, directly or indirectly, to the 30 COVID-19 pandemic; (2) 1 or more individuals within the household can 31

demonstrate a risk of experiencing homelessness or housing instability; and (3) the household is a low-income family as defined in 42 U.S.C. 1437a(b). The eligibility criteria may be further amended by the Mayor, or his designee, so long as such amendments are consistent with, and permitted under, the ARP Act and applicable guidance from the U.S. Department of Treasury.

7 The ERA 2 Program Funds may be used for payment of rent, rental 8 arrears, utilities and home energy costs, utilities and home energy 9 costs arrears, and other expenses related to housing as authorized 10 by the ARP Act. The ERA 2 Program Funds may be used to provide financial assistance to eligible households for a period not to exceed 11 12 18 months. In the event an eligible household received financial assistance under the Consolidated Appropriations Act of 2021 13 Emergency Rental Assistance Program (the "ERA 1 Program"), the 14 aggregate amount of financial assistance an eligible household may 15 receive under the ERA 2 Program when combined with financial 16 17 assistance provided under the ERA 1 Program, shall not exceed 18 Distribution of the ERA 2 Program Funds and local 18 months. 19 administration of the ERA 2 Program shall be conducted in compliance 20 with the ARP Act, applicable guidance from the U.S. Department of 21 Treasury, and the terms and conditions of the U.S. Department of 22 Treasury Emergency Rental Assistance grant award and the 23 corresponding list of Allocations to States and Eligible Units of 24 Local Government, copies of which are attached hereto as Exhibit 2 25 and incorporated herein by this reference.

26 Section 3. Carryover. The funds appropriated herein shall 27 not lapse but shall carryover as appropriated from year to year until 28 such funds are expended or lapse.

Section 4. Invoking the exception to Section 126.107(g),
Ordinance Code. The City is hereby authorized to directly procure
the use of the professional services of Civitas, LLC for the

distribution of ERA 2 Program Funds to eligible households in 1 accordance with the ARP Act and applicable guidance from the U.S. 2 Department of Treasury. Pursuant to Section 126.107(g) (Exemptions), 3 Part 1 (General Regulations), Chapter 126 (Procurement Code), 4 5 Ordinance Code, such procurement is exempted from competitive solicitation because the supplies or services are to be provided by 6 7 those specifically prescribed within authorizing legislation that With the exception of the foregoing, all 8 appropriates the same. 9 other provisions of Chapter 126, Ordinance Code, shall remain in full 10 force and effect. The Scope of Services and Fee Schedule more particularly described in **Exhibit 3**, attached hereto and incorporated 11 herein by this reference, designates the specific services to be 12 performed by Civitas, LLC as a subcontractor for the City. The Scope 13 of Services and Fee Schedule may include such additions, deletions 14 15 and changes as may be reasonable, necessary and incidental for carrying out the purposes thereof, as may be acceptable to the Mayor, 16 17 or his designee; provided however, such modifications shall be technical only, subject to appropriate legal review and approval by 18 19 the Office of General Counsel, and shall be undertaken in compliance 20 with any applicable requirements of the ARP Act and related laws, 21 consistent with the intent of this ordinance. For the purposes of this ordinance, the term "technical changes" is defined as those 22 23 changes having no financial impact to the City and any other non-24 substantive changes.

25 Approval and authorization to Section 5. execute an 26 agreement between the City and Civitas, LLC. The Mayor, or his designee, and the Corporation Secretary are hereby authorized to 27 28 execute and deliver on behalf of the City an agreement with Civitas, 29 LLC, in an amount not to exceed \$30,068,272.07, subject to the Scope of Services and Fee Schedule more particularly described in Exhibit 30 3, for a contract term commencing September 1, 2021 through September 31

30, 2022, and all other contracts and documents, including extensions, renewals and amendments to the agreement, and otherwise take all action necessary to effectuate the intent of this Ordinance, subject to appropriate legal review and approval by the General Counsel, or his or her designee, and the City's Risk Management Division for appropriate insurance and indemnification requirements in accordance with Section 128.601, Ordinance Code.

8 Section 6. Waiving Section 110.112, Ordinance Code. 9 Section 110.112 (Advance of City funds; prohibition against), Part 1 10 (The City Treasury), Chapter 110 (City Treasury), Ordinance Code, is 11 hereby waived to allow for advance payment to Civitas, LLC, as 12 described in Section 1.

13 Section 7. Further authorizations. The Mayor, or his designee, is hereby authorized to reallocate ERA 2 Program Funds as 14 15 necessary to effectuate the intent of this Ordinance, including but not limited to, transferring ERA 2 Program Funds between line items 16 17 reflected on Exhibit 1, so long as any such reallocation is consistent with the ARP Act and all other laws, rules and regulations applicable 18 19 to the ERA 2 Program and expenditure of the ERA 2 Program Funds. The 20 Mayor, or his designee, is further authorized to procure services and 21 support from additional subcontractors and vendors, subject to the 22 provisions of Chapter 126, Ordinance Code, as needed for effective and efficient administration of the ERA 2 Program, consistent with 23 24 the intent of the ARP Act and this Ordinance.

25 Section 8. Oversight Department. The Housing and 26 Community Development Division, Neighborhoods Department shall 27 provide oversight for all contracts and expenditures authorized 28 hereunder.

29 Section 9. Compliance with applicable grant funding 30 requirements. Civitas, LLC will comply with all grant requirements 31 of the ARP Act and all other requirements provided by law including,

but not limited to, the audit requirements attached hereto as Exhibit
 4 and incorporated herein by this reference, in administering the ERA
 2 Program and providing services related thereto.

4 Section 10. Requesting emergency passage upon introduction pursuant to Council Rule 4.901. 5 Emergency passage of this 6 legislation is requested upon introduction. The nature of the 7 emergency is that the negative economic impacts of COVID-19 are ongoing and immediate economic assistance is needed to ensure eligible 8 individuals and families can retain their homes. 9

Section 11. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
