The Friends of Brentwood Public Library, (FOBL) Inc. is a nonprofit organization that's exclusively charitable, and educational. For the past eight years (8) FOBL has been a strong advocate for the JPL (Jacksonville Public Library) Friends Group. We provide educational outreach pro-literacy programs through the active and continued use of the Brentwood Branch Urban Core Library. We advocate for a public library system that meets its mission to the citizens of the community; building active public support for the branch library in the Brentwood Neighborhood; research data that impacts decisions involving maintaining and/or expanding access to Brentwood Branch Urban Core Library supporting needs and the community.

The James Weldon Johnson Young Writers Festival is an Arts and Humanities Literature Program. It is just one of the FOBL urban core educational community outreach initiatives.

The James Weldon Johnson Young Writers Festival mission statement: To use poetry, visual and performing arts as a vehicle to impact youth academic engagement and performance; social-emotional development and to develop writing and analytical skills giving children and youth a greater understanding of themselves and others.

- 1. Conduct a 3-day series of workshops introducing team building, writing, visual and performing arts skills. Subsequent sessions will include building self-esteem, strategies of effective writing, reading, and increase skills in visual and performing arts. Students will be able to interact with community writers about their topics and communication interest.
- 2. Young Authors Awards Ceremony will recognize all student participants completing instructional requirements for poetry submission, the reading list, poetry journal, and participating in a 3-day series workshops listed above. Eighteen cash awards will be presented to the winning young authors. Judging will be done by independent judges who have significant writing or educational expects in writing and assessment.
- 3. Family Fun Community Celebratory to include but not limited to artists entertainment showcase, pop up poetry, food vendors, and more.
- 4. Community of Writers Book Exhibits (Children and Adults)
- 5. Career Tour Day to motivate interest in higher education.

The program goals and objectives will be attained with support from FOBL community partners: Jacksonville Public Library, Friends of James Weldon Johnson Park, University of North Florida, Florida Authors and Publishers Association, Retired Educators/Community Writers, and Alycia Powers, an Associate Producer for Inside Edition. She is an award-winning journalist who currently covers a wide range of national stories. We have other pending partners with our similar mission.

We will use several ongoing evaluation strategies to measure outcomes, fuel improvement, analyzing data collected to serve our community more effectively. The success of the program will be based on the following criteria:

- (1) Number of youths enrolled
- (2) Number of youths completing the program workshops, reading list, fiction poetry journal, and following poetry and monologue competition submission rules.
- (3) Pre- and post-surveys will be given to every student to assess knowledge gained from activities.
- (4) The awareness of college, vocation interests, and community writer's careers.
- (5) Keep attendance of all youth activities.
- (6) Surveys will be given to each youth participant to evaluate workshop series and presenters.

(ii) National Research & Analysis

National Endowment for the Arts Research: Poetry Out Loud connects students with literary heritage, instills a sense of poise and confidence, and in some cases, transform lives, The program helps students to master public speaking and build self-confidence, which can be critical for young people finding their way through adolescence.

The nation's longest running, most prestigious recognition program for creative teens in grades 7-12 from public, private, or home schools can apply in 28 categories of art and writing for their chance to have their works exhibited and published. Last year 320,000 works were submitted."

(iii). We anticipate enrolling 150 elementary, middle, high school students and their families. The Family Fun Celebratory Day will be open to the public. We anticipate at least 300 or more in attendance at the JWJ Park event. The community will benefit from the positive perceptions of poetry listed above.

The James Weldon John Poetry Contest (now the James Weldon Johnson Young Writers Festival, 2021) A CHRONOLOGY

The James Weldon Johnson Young Writer's Festival initiative was established by Sharon Coon in 1992, as the James Weldon Johnson Poetry Contest, honoring Jacksonville's native son and Florida's true poet laureate of the 20th century. In an effort to expand and enhance the opportunities at Tots 'N' Teens, an African American Multidisciplinary Cultural Arts Center, and to honor James Weldon Johnson, native of Jacksonville and Florida's true poet laureate of the 20th century. Mrs. Coon introduced to her board of directors the idea of an annual James Weldon Johnson Poetry Contest. The board approved. The plans were made to implement the contest in 1992.

Since 1992, The James Weldon Johnson Poetry Contest has offered an excellent opportunity for students in grades 1-12 to express their creative potential in poetry and to be judged by several local published poets. Three categories for participation have been established: Elementary School (grades1-5), Middle school (grades 6-8), High school) grades 9-12). Three prizes are awarded in each category: first prize, second prize and third prize. Honorable mention is given to other poems of meritorious quality. Each participant receives a certificate of participation.

The Poetry Contest has grown in its four years of existence in numbers of categories participants and in the quality of original composition. Fifty-eight (58) poems were entered in the competition from four (4) elementary schools, West Riverside Elementary, Brentwood Elementary, Martin Luther King Elementary, Sherwood Forest Elementary, and from students at Tots 'N' Teens Theatre, Inc.

In 1995, two hundred thirty-two poems were entered in competition from nine (9) elementary schools, five (5) middle schools and eight (8) high schools. The greatest growth has occurred at the high school level from no entries in 1992 to one hundred twelve (112) entries in 1995. The awards reception has been sponsored by Southern Bell for the past three year at the Tower in Downtown Jacksonville.

In 2000, The James Weldon Johnson Poetry was an event of the James Weldon Johnson Festival established by Sharon Coon. The awards luncheon was sponsored by Blue Cross of Blue Shield at the Prime Osborn Convention Center.

In 2021, The James Weldon Johnson Young Writer's became a part of the Friends of Brentwood Public Library Urban Core Outreach Program. This year forty-five (45) poems were entered in the competition from four (4) elementary schools, (5) middle high schools, and (2) senior high schools. The awards ceremony was co-sponsored by the Honorable CM Reggie Gaffney at the James Weldon Johnson Park.
